

Stephen Daley, 64, of 1360 W. State St., died suddenly from a heart attack this morning at 5:05.



His mother, Eliza Aldred, married 19 Nov 1870 in Leigh, Lancashire, England to James Isherwood. William Aldred bore his mother's maiden surname & was born 13 months before her marriage to Isherwood.

Emigrated to the US in 1907, having sailed on "Haverford" from Liverpool, England & arriving in Philadelphia PA on 22 Jul 1907. William was age 36, born West Leigh, England. He lists his stepfather as James Isherwood.

The rest of the family – wife Christine & children Elizabeth, Alexander, James, Nicholas, Jeremiah, Evelyn, Edna May – came from Leigh, Lancashire, England, in 1910. They settled in Amsterdam, Jefferson OH.

His Ohio death record lists his father as James "Ishawood" and his mother as Eliza Aldred, both born England.

Christina McKenzie Gibson's mother was Nicholas Gibson (1844 Scotland- 1899 England). Christina will give her own daughter the first name of Nicholas. Nicholas Gibson married George Russell (1849 England – 1929 England) on 31 Dec 1873 in the High Church, Paisley, Renfrewshire, Scotland but had given birth to Christina Gibson in Nov 1872. According to the above note on Ancestry.com, Christina's biological father is George Russell.

When Christine & children immigrate in 1907, her father is listed as George Russell – or as George Russell Isherwood [placement of names is unclear].

On her daughter Eliza's marriage record & her daughter Christine's 2nd marriage record, Christine's birth surname is listed as McKenzie.

On her son James's marriage record, son Jeremiah's marriage record, daughter Edna's marriage record & son Earl's marriage record, Christine's birth surname is recorded as Russell.

Her mother Nicholas Gibson later married Robert McAlister. It is unclear where the surname McKenzie derives from.

Richard Stanley Lee was born 4 Mar 1897 in Bergholz, Jefferson OH & died 8 Mar 1977 in Canton, Stark OH. He is buried in Sunset Hills Burial Park, Canton, Stark OH, F: 100579403.

In the 1930 census for Canton, Stark OH, Richard S. Lee (33 OH, beader of enamel ware) was the head of household which included his wife Edna E. Lee (27 OH, 1st married at age 18, employed in power sewing of tire covers), his stepdaughter Mary C. Aldred (7 OH, father b. England, mother OH), his father-in-law Joseph A. Mason (69 OH, widowed) & his sister-in-law Ethel F. Mason (22 OH, single, employed in power sewing of tire covers). In the 1950
