Plans for the second dinner of the newly formed Problem Club were announced this morning by Charles L. Ambler, secretary of the organization. The first dinner was held in July and was a big success, and now that the Summer is over and practically all the villagers have returned from their annual vacations, the officials of the club feel that a large number of townspeople will avail themselves of the opportunity to learn about the new city charter which has been in the process of formation for almost two years.

As is customary at the dinners held by the Problem Club, there are two speakers to present the particular subject chosen for the dinner. These speeches are followed by general discussion on the part of all those present, so that all may state their views. Almost 100 gathered for the first dinner.

The Ossining Problem Club was formed in June, with the purpose of meeting twice a month. The second meeting of the month has been set aside as a dinner meeting. At the first meeting of each month, the Board of Directors of the club hold a meeting, at which time they decide on the particular topic for the month, after which they select their speakers, and make arrangements for the dinner. The club was formed for the purpose of non-partisan public discussion of pressing civic problems, in an effort to solve those problems for the good of the village.

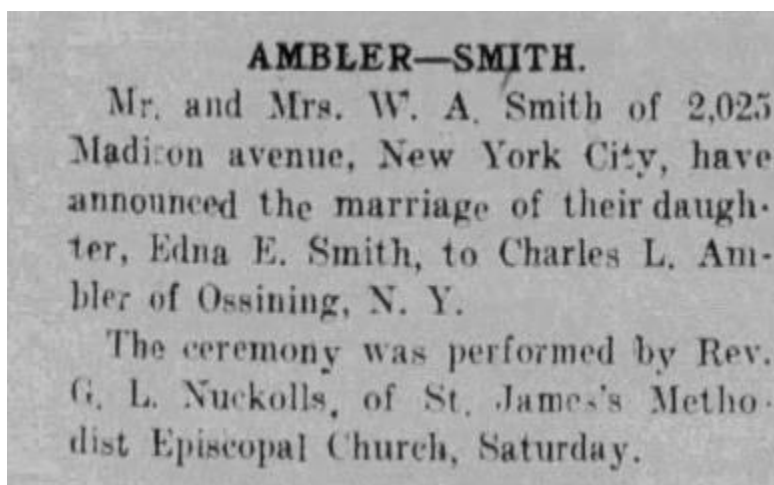

THEIR BREAK FOR LIBERTY.

TWO SING SING CONVICTS OVERPOWER A KEEPER BUT ARE RECAPTURED.

SING SING, N. Y., April 11.—Two convicts in Sing Sing Prison, James Kelley and Michael Feeney, made a desperate attempt to escape this afternoon. A little after 2 o'clock Keeper Leander See took these men from the main prison up to the old female prison on the hill to clean up for the men who are usually locked up there. This has been the daily custom for a long time. The three entered the building, and then the convicts sprang on Lee and overpowered him. Kelley, who had a hammer concealed on his person, dealt the keeper a heavy blow on the top of the forehead, cutting the skin and causing the blood to flow freely.

See is a man about sixty years of age and not very strong. Kelley soon overpowered him and tied him up hand and foot with a piece of rope. The men then took his revolver and keys away from him. They pushed another convict, August Kline, whose duties were to look after the lamps, into a cell and locked him in. They then went to Keeper E. M. Pierce's room, where they helped themselves to two suits of citizens' clothes. By means of the keys they had taken from Keeper See they let themselves out of a side door, out of sight of the prison office.

Meanwhile Keeper See had managed to untie the rope around his feet, and with his wrists still firmly bound, he hastened down to the office and gave the alarm. Keeper George N. Bronson, with Charles L. Ambler, a citizen, started off toward Long Hill, east of the prison, and when they had reached the Titlar farm, about three miles from the prison, they caught sight of the fugitives sitting by a stone wall. The convicts were approached unobserved and were astonished almost out of their wits by the order, "Hold up your hands!" They turned and saw two revolvers covering them and made an unconditional surrender. They were then disarmed and marched back to the prison.

Kelley was sentenced, Jan. 11, 1889, for five years, for grand larceny, by Judge Gildersleeve, in New-York. Feeney was sentenced Sept. 19, 1889, for ten years, for assault with intent to kill Keeper Gay, in Clinton Prison, while serving a twenty years' sentence there. Both are desperate men. An effort has recently been made to have Feeney pardoned, on the ground that he acted in self-defense in killing Keeper Gay.

These fifteen were taken from the eligible lists. They were the only ones on those lists of 150 not in permanent employment. As the remaining 120 will not throw up steady jobs to serve the Government thirty days, the remaining fifteen storekeepers needed will have to come from some other quarter.

Grace A. Burdick, 71, native of Ossining, former building department secretary and active member of Trinity Episcopal Church died Saturday at Phelps Memorial Hospital in North Tarrytown. She lived at 39 Somerstown Road.

Mrs. Burdick had spent a portion of her last day watching and applauding the Westchester County Volunteer Firemen's Association parade in Ossining. "She had a ball," said her daughter, Mrs. Thomas (Grace) Di Cuirci, today. "She loved the firemen and the Ossining department."

She was taken to the hospital where she died later that day, having suffered a heart attack at home.

Mrs. Burdick served as secretary for the Ossining building department for 10 years, from 1964 to 1974 when she retired.

"She was great help to me when I came in 1968," said Robert Emerick, building inspector. "She was great gal, a swell person, and she really knew the village—she knew things people don't have written down."

She had long been active in Trinity Church affairs and had helped to establish the church thrift shop. She had also worked on the annual church fair, running the crafts booth.

She had been active also in local politics, and during the 1950s served as president of the Ossining Women's Republican Club.

Mrs. Burdick was born in Ossining June 11, 1903, a daughter of Charles and Lillian Ambler. She was married to William Burdick, who died in 1958.

She is survived by her daughter, Mrs. Di Cuirci of the home address, and two grandchildren.

The 26-foot pole, owned by O. E. Cherry of 69 Hunter Street, was rotten at the base.

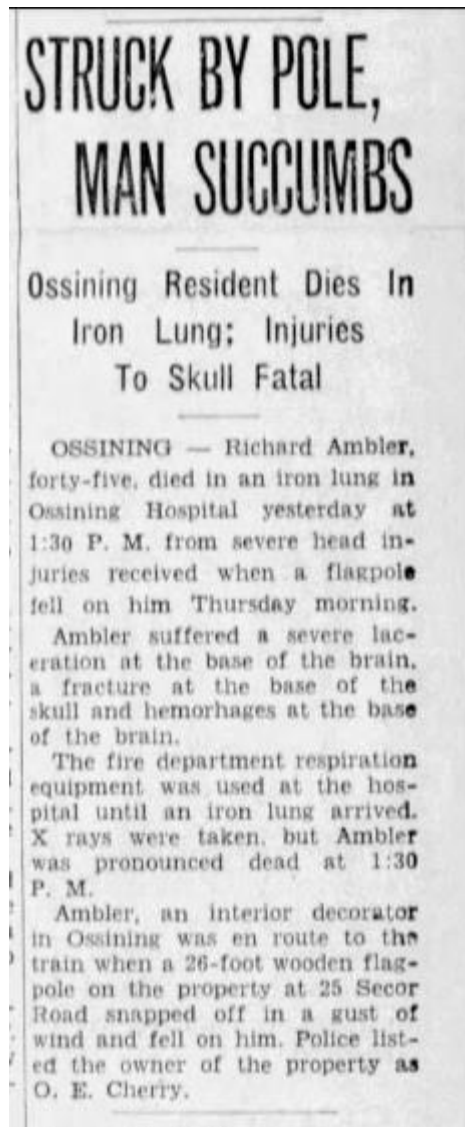
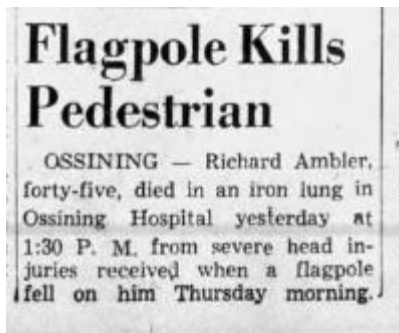
Mr. Ambler is unable to be moved even for X rays, not able to breathe without aid, and suffering a brain hemorrhage, and possible skull fracture.

An iron lung, loaned by the Infantile Paralysis Chapter, is being sent to the hospital by truck to aid Mr. Ambler.
