ELKO BIDS ADIEU TO SOLDIER BOYS

Third Increment Departs For
Camp Lewis on No.
19 Today

The last contingent of the first men from Elko county selected to serve in the United States army will depart on No. 19 this afternoon which is several hours late. Appropriate exercises were held in their honor at the court house at one o'clock this afternoon. A stirring address was delivered by Judge E. J. L. Taber, who highly praised the splendid spirit with which the boys go forth, and flayed the meanness of the certain few who have refused to contribute to the support of our boys at the front, although well able to do so.

The meeting was presided over by Attorney J. M. McNamara, who also made an able and patriotic address.

A large crowd was present, the court room being crowded to capacity with scores standing in the corridor. The Elko band played patriotic hymns and the high school cadet corps attended in a body, commanded by Professor George Jensen. It was one of the most patriotic gatherings that ever assembled in Elko, and if the same spirit exists all over the state, Nevada will do her part in this great war with Germany.

To the boys who leave today, as to those who went before, we say good-bye, and God bless you. We hate to lose you from our midst, but our country has called and it is your most sacred duty to go. We envy the youth and strength that is yours, and the opportunity you have to serve humanity. Some of you may not return. So be it. "Where man's blood is shed for man, that spot is hallowed ground," and only the coward, the craven, is not willing to give his last drop of blood for the freedom of humanity.

When the war is over we will welcome you back with open arms, and never will we forget that we owe to you a debt of gratitude that can never be paid. All honor to you, good-bye, and God bless you.

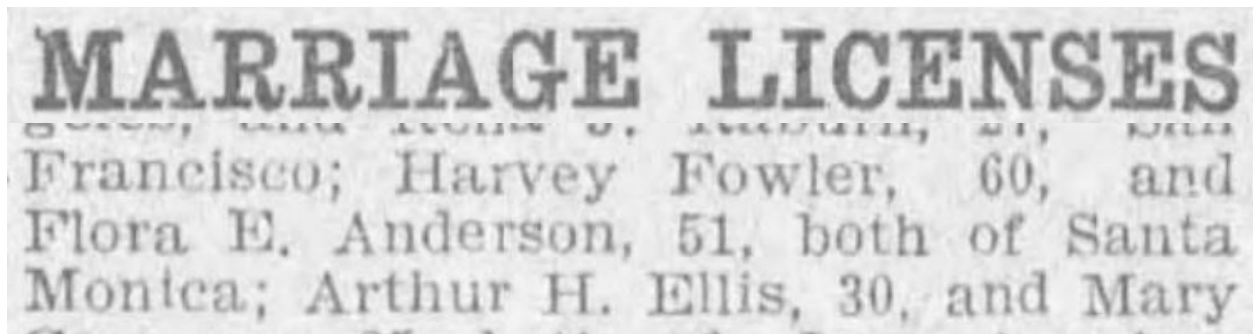

BACK TO SAN QUENTIN.

Judge Shafter Denies Harvey Fowler's Petition for Habeas Corpus.

Judge Shafter yesterday discharged the writ of habeas corpus sued out by Carroll Cook on behalf of convict Harvey Fowler, and ordered the petitioner remanded to the custody of Warden McComb.

Fowler, otherwise known as John Wilson and John Lathrop, was convicted in Santa Barbara on June 12, 1889, of having placed Rosa Keef, a minor, in a house of ill-fame, and it was also shown that he had on January 26, 1882, been convicted of burglary in San Jose. His Santa Barbara crime, which constitutes a felony in the eyes of the law, gained him ten years in San Quentin, from which institution he sought to obtain his release under the proceedings which have just now been dismissed.

The counsel, Carroll Cook, advanced the technical point in his behalf that his commitment had not set forth the particulars of the crime for which he had been convicted, only stating that it was a felony. On this ground the counsel claimed that his imprisonment was illegal.

Judge Shafter held otherwise and remanded the petitioner.

WIFE DESERTS BLIND HUSBAND IN LOCAL HOSPITAL TO ELOPE TO NAPA WITH SPOUSE NO. 1

Harvey Fowler Calls Upon Police To Arrest
His Wife Who is Believed To Have Run
Away With Ambrose Grow.

In an effort to cover her trail in eloping with her first husband Mrs. Harvey Fowler had a telephone message sent to Mrs. Tibbetts of this city stating that she had dropped dead in St. Helena last Tuesday but Fowler who is blind and infirm in an effort to learn particulars of her death discovered that she is not dead and has asked Sheriff Kelton of Napa to arrest the couple.

Fowler has been at the county hospital in Martinez since last Monday when he was taken there by his wife who said he was to have an operation performed by Dr. Merrieth upon his eyes, by which he hoped to regain his sight. Fowler was in a drunken condition and the hospital attendants spent a sleepless night caring for him and finally located the bottle of liquor of which he was imbibing. The next day Mrs. Fowler disappeared after removing all of the furniture from the house where the couple had been living near the marble works in Main street and taking all of her husband's \$50 pension money except \$2.

In Napa Mrs. Fowler is said to

have met Ambrose Grow who is well known in that city, her former husband and the two are now believed to be some where in that vicinity. Fowler was taken to Napa Sunday from the hospital and is staying at the Napa hotel.

The Fowlers came here about one year ago from Tulare county and during the past year Mrs. Fowler has taken in washing to make a living, at the same time drawing \$10 per month for the support of herself and husband from the county. It is said that the couple formerly begged on the streets of Richmond, asking support for their family of little children. Mrs. Fowler is reported to have two sons and one daughter by her former marriage. Fowler says that they were married in Los Angeles in 1907.

The case which has now been revealed in all of its ugly aspects has stirred considerable notoriety in this city on account of the old G. A. R. veteran who was unable to work and who was dependent upon the wife who has now deserted him. Fowler will go to the Veterans' Home at Yountville.

Sheriffs Seeking for Blind Veteran's Wife

MARTINEZ, December 14.—Sheriff R. R. Veale has asked Sheriff Kelton of Napa county to arrest the wife of Harvey Fowler, a blind veteran of the Civil War, who was taken to the County Hospital last Monday. The woman, according to Veale, is said to have telephoned from St. Helena that she was dead, and was also alleged to have eloped with a former husband, Ambrose Grow, also a Civil War veteran. Kelton reported the woman was alive and Grow had departed. He was asked to arrest the pair.

According to Veale, it is asserted that Fowler's wife drew her husband's pension of \$90, disposed of his furniture and left, leaving the blind veteran but \$2. Fowler will go to the Old Soldiers' Home at Yountville.

When Harvey Fowler, the former blind inmate of the Martinez hospital refused to swear to a warrant for the arrest of his wife who is alleged by him to have eloped with Ambrose Grow, said to be her first husband, Sheriff E. A. Kelton refused to take further action and dropped the case forthwith.

Grow and Mrs. Fowler are believed to be in Napa and Fowler has gone on to the Veterans' Home at Yountville where he will be cared for.

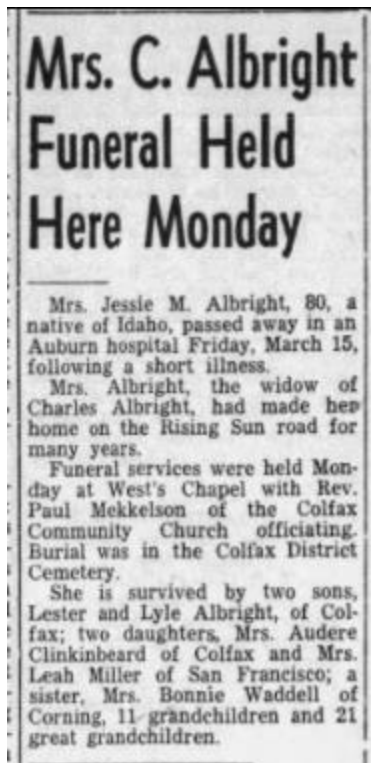

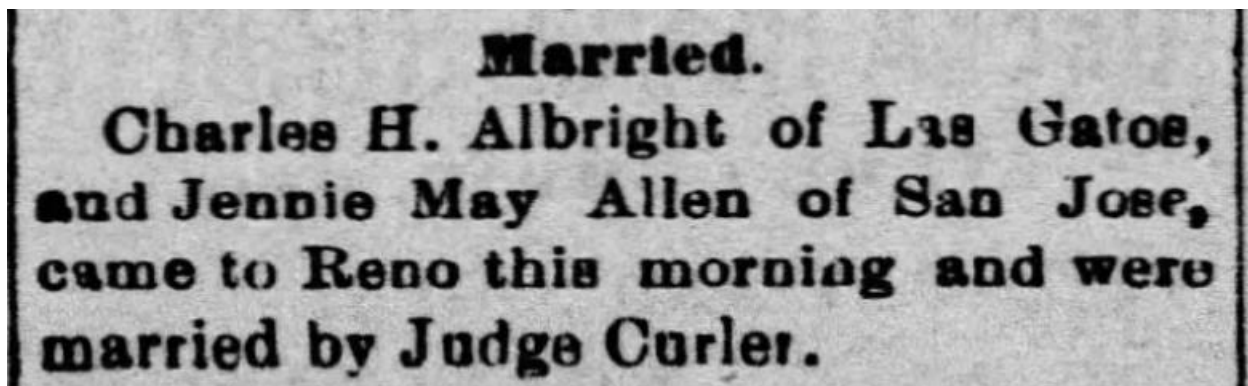

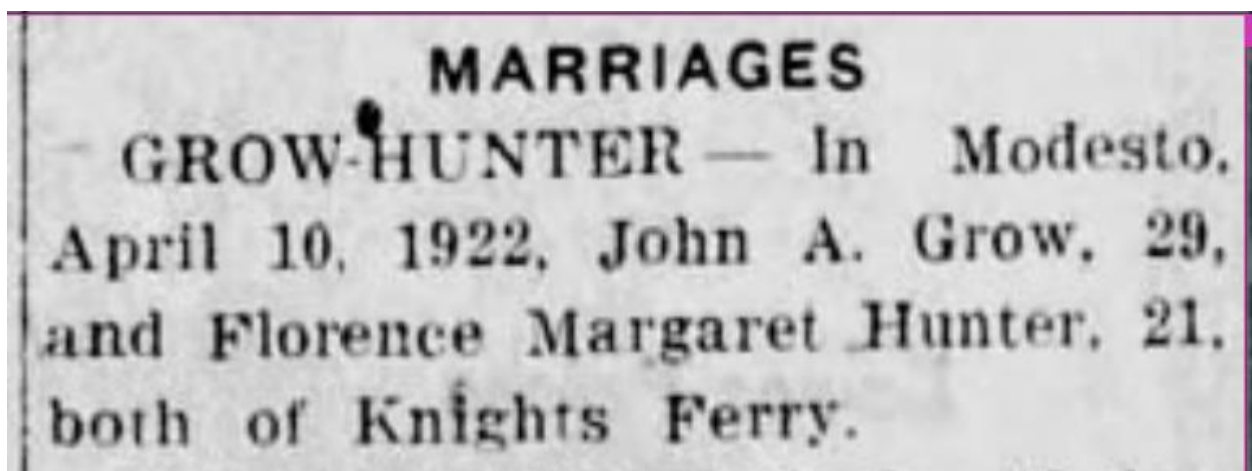

CARSON CITY MAN MEETS INSTANT DEATH IN CRASH

Hurled from Truck, Strikes
Automobile Windshield
And Is Decapitated

Thrown from the rear end of a truck as it swerved to avoid striking another car, and catapulted into the windshield of an east-bound vehicle, Harvey L. Grow, Carson plumber, met instant death on the highway at Coney Island in Sparks early last evening.

Grow crashed through the windshield of the vehicle and his head was severed and hurtled twenty feet across the highway. A small child he had been holding in his arms before the accident, dropped to the floor of the truck and was not injured.

The truck was driven by Grow's brother, John A. Grow of Sparks. Seated on a box in the rear of the vehicle with Grow was his mother, Mrs. Flora Grow, and the small child. John Grow told police he was attempting to pass another car at Coney Island when a headlight loomed and he swerved the truck to avoid a collision.

Grow lost his balance when the truck swerved and was hurled clear of the car, crashing head-on into an east-bound automobile operated by James Sutton of Reno. He struck the windshield of the car, shattering the glass. His body glanced off the Sutton car and was struck by a vehicle driven by Clint Nichols of Reno and knocked to the ground at the edge of the pavement.

Motorists home-bound from their work collected at the scene instantly and a traffic jam which lasted for several minutes resulted.

Occupants of the Sutton machine were cut by flying glass but their injuries were said to be not serious. The occupants were, besides Mr. Sutton, his wife, Mrs. James Sutton and their baby daughter, and Mrs. S. F. Graves. Nichols was not injured when his car struck the body. All participants in the accident were exonerated from blame by the police. An inquest will be held in the justice court at Sparks tomorrow by Coroner Cunningham.

Grow was thirty-seven years old and was a native of California. He had conducted a plumbing shop at Carson for several years. He is survived by his mother, Mrs. Flora Grow of Carson and two brothers, John A. Grow of Sparks and Frank Anderson of Tuscarora, Nev. The body is at the Ross-Burke Company and funeral arrangements will be announced later.

The family also drew on \$10 county support per month. In the 1920 census for Table Rock, Siskiyou CA, Nellie Fowler, 64 CA, widow, race white, father b. OH, mother b. IN lives with her son John A. Grow (25 WA, father b. IN, mother b. CA), a laborer in a lumber mill.

In 1930, Nellie Fowler, 75 CA, an Indian, lives in Carson City, Ormsby NV, 1st married at age 45 (?), lives with her husband Harvy [sic] Fowler, 83 MO, also an Indian.

In 1940, Flora Grow, 84 CA, widow, lives in Placer Co. CA, listed as the grandmother of Frank & Bonnie Wadell.

She is buried as Flora Ellen (Goodwin) Grow in El Dorado Cemetery, El Dorado, El Dorado CA. Harvey is buried in Long Mountain Cemetery, Carson City, Carson City NV, F: 38945283. He had been a private in Co. I., 2nd CA Infantry in the Civil War.
