



WASHINGTON, Febrero 11.—En las listas adicionales de los supervivientes del trasatlántico "Tuscania", echado a pique el martes de la semana pasada frente a las costas irlandesas por un submarino alemán, figuran los nobres de otros noventa y dos soldados reclutados en el Estado de Texas, entre los que se encuentran nueve méxico-texanos, cuyos nombres son los siguientes:






