

Sentenced For Tax Law Violation

Henry J. Askew Jr., of Corpus Christi and a former San Antonio resident, was sentenced April 3 by U.S. District Judge Ernest Guinn in San Antonio for violating the feceral income tax law.

Askew received a two-year sentence, with six months to serve and the balance suspended. He is free on bond pending appeal.

Askew was indicted in April, 1965, by a federal grand jury in El Paso on six counts of income tax violations. Three counts charged that Askew reported total taxable income for 1958, 1959 and 1960 of \$38,348.96 with a tax liability of \$9,332.63 when his corrected taxable income for the threeyear period was actually \$77,045.55 on which there was a tax liability of \$23,200.22.

The other three counts charged that Askew filed false c o r p o r a t i o n income tax returns for Browning Mfg. Co. of San Antonio on which he claimed deductions totaling \$178,523.29 for the three years for travel and entertainment and these amounts were falsety and grossly overstated.

Askew was first tried in San Antonio in August 1967, and the trial ended in a mistrial when the jury was unable to reach a verdict. Askew waived a jury trial for the second trial and Judge Guinn found him guilty.


