



FIRE DESTROYS STORE BUILDING AT GREENVILLE

Two Story Lake Building Burns With Heavy Losses

GREENVILLE, Miss., May 20 (AP)—An early morning fire of undetermined origin today swept through the second floor of the two story Lake building in the business district on Main street causing damage estimated at from \$25,000 to \$30,000 and injuring two firemen. Four occupants of rooms on the second floor escaped in scanty attire.

Lieutenant Otis Goodin, of Hose Co. No. 1, suffered painful injuries and Captain W. G. Chipman was slightly hurt by falling bricks while fighting the fire. Goodin, taken to Kings Daughters Hospital, was reported by attending physician suffering from a fractured shoulder blade and a cut about the head.

G. A. Ratterree, 60, E. L. Riggers, 49 and Frank J. Ackerson, 46, awakened by smoke that filled their rooms, climbed through windows to roofs of adjoining buildings to safety and David Dicks, a blind furniture salesman, was rescued from flaming structure by Captain Chipman.

The fire started upstairs in the rear of the building and patrolman S. L. Moran, making his rounds, turned in an alarm. Flames jumped high in the air and billows of smoke poured from the burning building. City firemen with a fire engine pumper and six lines of hose halted the blaze after it threatened for a time to destroy an entire business block, including the plant of the Daily Democrat Times.

Tatum furniture store and Wileys Auto Parts on the first floor and Wileys Elecertic Station were damaged by water.

The rear section of the roof

was destroyed.

C. A. Tatum estimated the fire damage to furniture in the upstairs wareroom at between \$7,-000 and \$8,000. He said the damage was partially covered by insurance.

J. A. Lake, Sr., owner of the building, could not immediately estimate the loss but the damage was expected to reach several thousand dollars.

GIRL'S HAND CRUSHED.

Irene Ackerson Hurt at Crown Laundry Early Today.

Miss Irene Ackerson, an employee of the Crown laundry, while working with a hot mangle this morning, got her hand in the machine and it was crushed to the middle of the hand and was badly burned beside.

The mangle is composed of two iron rollers through which garments are passed to press them. One of the rollers is hot and the other one is cold. Miss Ackerson was putting a garment into the mangle when it caught her finger and before it was stopped it drew her hand into it nearly to her wrist, crushing the flesh and bones and burning the flesh very badly.

The worst feature of the wound is the burned flesh which will contract the muscles, drawing the hand shut. It is a serious wound, the burn making it worse than it would otherwise be. It is the hand which she uses most in her work.



WENT UP IN PLAMES.

"Limpy Joe's" Cab Will Cease to be An Eye Sore.

There was a fire in Salina about 12 o'clock last night, but as no alarm was sounded, only a few persons Witnessed the destruction of one of Salina's old time curiosities-the cab belonging to Joe Ackerson, better known as "Limpy Joe." The vehicle was one of the first cabs ever brought to Salins and had years ago been east away among the things of the past. The hack was used as a chicken coop for several years by a man living on the south side. Ackerson bought the cast away and repaired it for use and has for the past three years run it as a night hack. The vehicle which was an old rickety affair, was hardly fit for use and the other night hackmen offered Ackerson \$25 for the vehicle, which was accepted and yesterday the deal was made, the was taken to the vacant lot north of Fifth Street depot and last night the hackman warmed themselves from the heat furnished by the blaze which destroyed "Limpy Jo's" cab.

ARRESTED FOR ROBBERY.

Lewis Turner and Joe Ackerson Charged With Serious Crime.

As stated in Saturday's paper, Leon Werry was robbed of \$28 in the north end last Friday night, while in company with Lewis Turner, a colored fellow and Henry Ackerson, better known as "Limpy Joe" Werry appeared at the police station the next morning, in an intoxicated condition, and reported the robbery. As he was full the officers refused to do anything for him until he sobered up. Yesterday Werry came to town again and obtained a warrant from the County Attorny, charging Turner and Ackerson with highway robbery. The two men were arrested and arraigned before Justice Bishop and their cases were set for trial in Bishop's Court tomorrow. Ackerson was released on his personal recognizance and Turner was committed to jail in default of \$800 bond.

According to the story told to the officers, Werry was on a spree last Friday night and it ended up in Joe Ackerson's room in the old hotel building north of the Union Pacific depot. He had gone there with Joe and Lewis Turner about four o'clock in the morning. Werry was sitting on the bed while Joe was making some coffee over the fire, when he (Werry) pulled some money out of his pocket and counted it A few moments afterward Turner approached him and shoving his hand in his pocket, took the money and skipped. The officers believe that they have a good case against Turner but a conviction of Ackerson is doubtful.

Jury Was Out Only Forty Minutes.

SHINN ROBBERY TRIAL.

The Well Known "Alpheus" Charged With Highway Robbery.

The criminal case of state vs. Louis Turner, colored, was called at the conclusion of the Lannan case yesterday afternoon. A jury was secured by four o'clock and the trial proceeded.

Turner was charged with robbing Leon Werry, a farmer of twenty-eight dollars, one night in the north end. The evidence given at the trial was very similar to that given at the preliminary. It showed that Werry went out one night to see the sights and in company with a hack driver, Henry Ackerson, better known as "Limpy Joe," he landed at Ackerson's rooms in the old hotel building north of

the Union Pacific depot about four o'clock in the morning. Turner came into Ackerson's room soon after their arrival and another colored fellow by the name of Hawkins was present during part of the night. Werry sent for a jug of whiskey and the four held a love feast. During the hours spent there, Ackerson flashed a roll of bills. After drinking for a while Turner left the room and soon afterward Werry missed his roll of bills. Turner was arrested the next day with Ackerson as his accomplice, but the latter was afterward discharged. The jury filed out to the jury room at 11 o'clock this morning and returned at 11:45 with a verdict of acquittal. The jurors in this case were: Frank Fager, J. W. Bell, A. F. Shute, Swan Nelson, J. Old Man, Convicted of Selling Booze, Allowed Freedom.

H. H. Ackerson, one of the men convicted in police court Saturday on a bootlegging charge and sentenced to 30 days in the county jail. has been paroled. In the case of Ackerson this was about all could be done. Ackerson is an old man, almost helpless and past the ags where he can support himself, and for sometime has been partially supported by the county. It was largely a question of whether his support would come cheaper in or out of jail and as his parole will probably stop his dealings in booze, it was thought best to allow him his freedom. The remainder of the bunch, convicted at the same time, who appealed their cases, are now in the county jail as they have not yet been able to give bond in the sum of \$300.

By 29 Dec 1930, she is listed as deceased in the Tulsa legal newspaper & Neal is handling her estate.
