CASPAR — Funeral services will be held at 11 a.m. Saturday in Fort Bragg for Stanley P. Brady, 72-year-old former resident of Caspar. He died Tuesday afternoon in a Willits hospital where he had been a patient for one month.

Mr. Brady was born in Calaveras county and grew up in Caspar. He was a retired mill worker and his present home was in Arroyo Grande.

Survivors include his wife, Ruth Brady, Arroyo Grande; brother, Walter Brady, Caspar; nephews, Elbert Montgomery and Wm. Montgomery, Fort Bragg and Alvin Crawford of Lornita.

He was a member of Fortuna VFW and a veteran of WWI.

Services will be conducted from the Cannarr-Fairlee Funeral Home in Fort Bragg. Burial will be in Caspar cemetery.

Stanley Brady, who resides with his parents at Caspar, fell from the waste carrier at the Caspar mill into the ash heap below last Tuesday and one arm was broken and the other badly injured. His face and head were badly lacerated also, and it was tedious work to separate the ashes and cinders from young Brady's anatomy. He fell a distance of about fifteen feet.

Casparites saw their first game of real football last Sunday. The contestants were the Caspar "Blues" and "Whites," and the result of all the fuss was 4 goals to 1, in favor of the "Blues."

While, from a critical standpoint, the game was crude, the players showed a grasp of the idea of soccer football and redeemed the game. The goal obtained by Billy Lawlor was the result of pretty team work in which Walter Owens, Pete Perkins and Lawlor himself figured conspicuously. Fleming's shot was low and hard and a good goal. Owens' point was from an opportunity gained for himself by his usual dashing style of play. But Perkins' kick was the most spectacular effort of the day, the ball sailing neatly over the heads of the "Whites'" defense and dropping in the corner of the goal so nicely that the goal-keeper had no chance to save. The solitary goal scored by the "Whites" was obtained by Stanley Brady, who rushed the ball through goal-keeper Bronson before the latter realized his intention.

At the close of the game the "Blues" played only ten men, I. A. Iverson being forced to retire with a twisted knee.

On Sunday, Sept. 29th, the "Whites" will try to regain their prestige in a game with the same team on the Fort Bragg baseball grounds. X

STANLEY BRADY NARROWLY ESCAPES DROWNING ON TUSCANIA

Stanley Brady of Caspar of the 20th Engineers was one of those aboard the ill-fated transport Tuscania when she went down off the Irish coast, the victim of a U-boat torpedo. Mr. Brady had a narrow escape and a harrowing experience, having been afloat 7 hours in an open boat. The following letter, which he wrote to his brother at Caspar, furnishes a graphic account of his escape:

Dear Brother Roy:—Will try and write you a few lines to let you know that I am as well as could be expected after the exposure I went through.

I do not know if this letter will be censored or not, but I heard that everything has been published in the U. S. papers, so I guess all I write will be o. k.

I was on the steamer Tuscania when she was sunk somewhere off the Irish coast. The life boat I was to leave in went off and left me, so I did not have any boat to leave the sinking ship in, and all I could do was walk around on the ship and wait for it to go down. After some time I saw a small boat being lowered and finally it got safely into the water and as not many were in it, I decided to take a chance, so I slid down a rope and landed safely in it. It was a little dingy boat that nobody had been ordered to use in case we were sunk.

We did not have any row-locks and we could not row the boat. All we could do was to drift with the wind. It was blowing awfully hard and the sea was very rough. We picked up one man, but could not take any more in because our boat was only fourteen feet long and had ten men in it.

We drifted with the wind for seven hours and finally we were washed up on the rocks on the south coast of Scotland at about 2 o'clock in the morning. It was awfully dark and we did not know where we were, but did not care as long as it was land. The first thing I did was to thank God for saving us and I guess all the others did the same. One boat came in just above us, and all were lost.

We found a small village and woke up some of the people. They took us in and we had some hot tea—it was the best I ever tasted. We were almost frozen and soaking wet. How we ever made land, I leave that to you to judge.

The people here certainly treated us fine. They gave us everything they had. We lost everything we had. I have nothing left but my life and a faint recollection of a wild night at sea in open boat.

At the spot where we landed up on the shore, there's where they buried the ones that were lost that floated into this little village.

Then on Sunday it rained some, and Sartor went to see his friends at Schooner Gulch and there he found a very interesting account of the shipwreck of the transport Tuscania off the Irish coast a few weeks ago. Stanley Brady of Caspar has in last week's Beacon given some account of this shipwreck, and Thomas Lynch of our town sent an account home, here, but on last Sunday Sartor read a very impressive account of 78 and 49 and 44, in all 171, soldier boys whose bodies were washed ashore and buried in three trenches on the shore of that Scottish island. Two ministers officiated and on the body of one of our soldiers a small silk flag was found and the ladies of that isolated community set up late in the night and made a flag of some size, ready to float old glory over the remains of so many prematurely dead and not yet upon the battlefield. Three volleys were fired and the national anthems of England and America were played in honor of the dead. Those bodies will be sent home when the war is ended.

Romance Wrecked

Aftermath Of War Revealed In Court

Scotch Bride Wins Divorce

A ROMANCE born at the altar of Mars, when uniforms and youth were synonyms for love, has been wrecked on the rocks of the prosaic and monotonous grind of peace times after the brass buttons had been laid away and the guns had stopped their deadly belching.

The story was told in Judge D. A. Cashin's department of the superior court by Annie Brady, whom the days of war saw as bonnie Annie MacGibbon, living the idyllic life of a simple Scotch maiden on one of the islands off the coast of Scotland.

The one time hero of the story, now turned into the "heavy" of the drama was Stanley Brady, in 1918 a khaki clad member of the American expeditionary forces to France.

Transport Wrecked

One day there came into the life of Annie MacGibbon and the pacific residents of Port Ellen, capital of a fairy island world, a flash of the lightning that was then electrifying the world. An American transport was submarined or wrecked and its soldiers were landed on the island.

Everyone was sympathetic to the American heroes, who came from out of the sea in the

night like so many wraiths. One of the crowd who ministered to their wants was the Scotch girl, then but 14 years old.

Mail Courtship

In the days that followed before another transport came to take away the doughboys, Stanley Brady, according to her story, pursued and made love to her. Then for the next three years they corresponded.

Their courtship by mail terminated when she succumbed to his pleas to come to America, where he would make her a home. They married in Hanford on September 26th, 1922.

Left Him Twice

While on their honeymoon her one time hero husband began making false charges against her, continuing it at varying intervals, after periods of ardent contrition and love-making, she charges. She left him twice, once to go to an uncle, living in Montana, another time to make her way as a house servant.

Then while tears sprang to the "war bride's eyes," though lit by a determination to somehow make good in this, her adopted land, Judge Cashin awarded her an interlocutory decree of divorce. Brady did not contest the case.

Blasted Love Told In Suit Shipwreck Romance Is On Rocks Veteran Of War, Defendant

A shipwreck, an acquaintance, four years of intensive love making by letter, numerous proposals, persuasions to leave her home across the seas, marriage and then—disillusionment.

Such is the story recited in a divorce action brought by pretty Annie Brady, a lass from bonnie Scotland, against Stanley Brady, formerly of Hanford and soldier in the A. E. F. The suit was filed yesterday.

Mrs. Brady became acquainted with her husband at Port Ellen, island of Islay, just off the coast of Scotland, during the World war, when Brady was rescued from a shipwreck. This was in February, 1918.

She was a mere girl, only 14, her complaint states, while Brady was a man of mature years, 28, and well versed in the ways of the world.

Brady was discharged from the army and returned to his home here. Four years of correspon-

dence terminated only when Mrs. Brady yielded to his persuasion to leave home and come to California to marry him, the complaint states.

Immediately after the marriage in Hanford on September 6, 1922, the couple left for a two weeks' honeymoon.

On September 20, 1922, while on their honeymoon in the Sequoia national park, Brady falsely charged his wife with infidelity, she claims. He continued to make these false accusations, she charges, even after they had gone to Coalinga to reside and where Mrs. Brady is living.

The wife left and went to San Francisco but finally yielded to her husband's promise to desist from his cruel treatment and returned. Again her husband falsely accused her, she charges.

She says she is in indigent circumstances and has to depend upon her own labor for support.

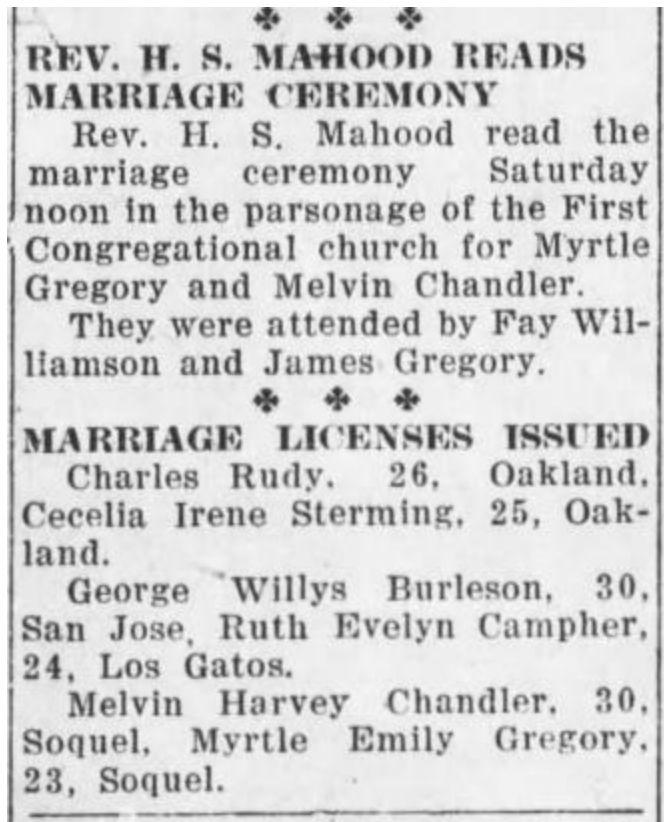

She was a native of Washington State and had lived in Mendocino County for 40 years.

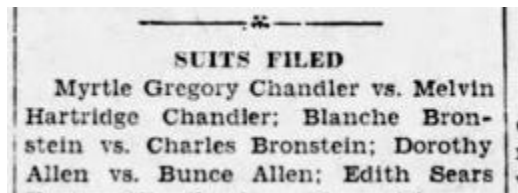

Resident of Port Ellen, isle of Islay, Scotland, age 14, when she met Stanley, when her grandmother Ann McGibbon housed Stanley & other soldiers after the sinking of the Tuscania. Wartime:

Although the local newspaper had reported Stanley was enlisting in the Army in Jul 1917 & he enlisted 5 Aug 1917 in the Army, recordkeeping seemed a bit inaccurate when he was said to have not reported to the draft board in Oct 1917 & then was declared a "slacker" in Dec 1917.

Post-war:

From Marilyn Gahm's "The Sinking of the Tuscania" at www.tuscaniamemorial.org: *In addition, survivors were billeted in Islay homes, about two or three in every house. Schoolgirl Isabelle Macgilvary recounted visiting them and singing to the men, including*

those at 8 Charlotte Street (the current Trout Fly Bed & Breakfast), then the residence and shop of Mrs. MacGibbon who cared for her motherless granddaughters, Anna and Mary. Four men were lodged in the local schoolhouse, with two apiece in the homes at the distillery. Edward C. Barker told his son Robert that he had been housed in the school. Supposedly Anna MacGibbon later moved to the U.S. and married one of the soldiers; that turned out to Stanley Pemberton Brady, in Hanford, California, in 1922, when she was 18.
