

Dr. John Buchanan, surgeon and ex-head of L.V. Dental Society

Dr. John Chatley Buchanan, 88, a retired dental surgeon, formerly of 2033 Washington Blvd., Wilson, died Tuesday in the Swaim Health Center, Newville, Cumberland County.

The husband of the late Marion (Rader) Buchanan, he resided at Green Ridge Village, Newville.

Chatley practiced in the Alpha building in Easton for 34 years before retiring in 1961. He was former chief of oral surgery at Warren Hospital and a former assistant chief at Easton Hospital.

A 1925 graduate of Temple School of Dentistry, he interned at Jefferson Hospital in Philadelphia.

He was the dentist for Northampton County Prison for 10 years, and for the Wilson School District. He was dentist emeritus of Easton High School.

Buchanan was a past president of the Lehigh Valley Dental Society and the Easton Dental Society, and former vice president of the Second District of the Pennsylvania Dental Society and former president of the Wilson Civil Service Board.

Born in Centralia, Columbia County, he was a son of the late John and Margaret (Griffeth) Buchanan.

He served in the Army Air Corps during World War I aboard the Tuscania which was torpedoed in the Atlantic. He later served in England, France and Germany.

He was a member of First Presbyterian Church, Easton.

Surviving are two daughters, Mrs. Carolyn Schubert and Mrs. Dorothy Petersen, both of Harrisburg; a brother James of Philadelphia; six grandchildren and two great-grandchildren.

Services will be at 10:30 a.m. Saturday in the Ashton Funeral Home, 14th and Northampton streets, Easton. Calling hours will precede the services.

St. Clair Boy On Tuscania

One resident of Schuylkill county and four others from the surrounding sections are reported officially by Washington officials as being on the transport Tuscania when it was torpedoed by a German submarine.

The men reported are:

John C. Buchanan, corporal; mother, Mrs. Margaret Buchanan, St. Clair.

Elmer E. Holmes, private; mother, Mrs. Anna Holmes, Lansford.

Floyd J. Price, private; mother, Mrs. Julia M. Price, Lansford.

Charles J. Fisher, private; mother, Mrs. Ellen Fisher, Jeddo.

Stanley V. Chesley, private; mother, Mrs. Julia Chesley, Coalport.

Owing to the survivors being scattered at different points and an authentic list not being checked, up to a late hour the government officials were unable to give out a list of the survivors.

Buchanan is one of four sons of Mr. and Mrs. John Buchanan, of St. Clair, in the United States service. He enlisted several months ago and made his way rapidly in the service, being promoted to a corporal some time ago. He was home on a furlough a little more than a month ago. Buchanan was attached to the 100th Aero Squadron.

He is a twin brother of Thomas Buchanan, who is in the Navy, while Will, another brother, is with Co. D at Camp Hancock. David, the fourth boy, is believed to be in France. He was em-

ployed at Ashland and Port Carbon drug stores for a number of years and enlisted in the Medical Corps. John graduated from the St. Clair H. S. last year.

The parents are wellknown north and south of the mountain, the father being a plumber, and was originally a resident of Centralia, removing to St. Clair a number of years ago.

Holmes and Price are both members of the 158th Aero Squadron, while Fisher and Chesley are members of the 213th Aero Squadron.

MEN ON THE TORPEDOED TUSCANIA

**Names of American Soldiers are
Arriving at the War
Department**

(By United Press Leased Wire)

WASHINGTON, Feb. 9.

Out of the war zone today come the names of hundreds of American boys saved from the torpedoed transport Tuscania to ease anxiety in the homes of this country.

The names are now being sent across the water in a steady stream and as rapidly as possible being compiled for publication. Not until the entire list is in will the War Department be able to check up and determine those who gave up their lives.

Those thus far announced include Charles K. Fisher, Oakdale, Jeddo, Pa.

Corporal John C. Buchanan, St. Clair, and Alfred Holmes, Lansford. Buchanan is one of four sons in the service, and belonged to the 100th Aero Squadron. He is a native of Centralia, Pa.

CENTRALIA BOY ON TUSCANIA

John Buchanan, a former Centralia boy, well known here, was one of the American soldiers on board the torpedoed Tuscania.

Buchanan is a native of Centralia, and moved with his parents, Mr. and Mrs. John Buchanan, of St. Clair five years ago. His aunt, Mrs. George Davis, resides in Centralia.

Buchanan's twin brother, Thomas, and two older brothers, David and William, are also in the Army. His father, a Spanish-American war veteran, was Centralia plumber.


ST. CLAIR BOY ABOARD THE TORPEDOED TUSCANIA



ST. CLAIR ELATED OVER SAFETY OF JOHN BUCHANAN

The announcement on Saturday evening of the safety of John J. Buchanan, who was on the transport *Tuscania*, torpedoed off the Irish coast last week brought a wave of relief to the people of the town who had taken almost as great an interest in the welfare of the young corporal as had his parents. Ever since the sinking of the ship the town has awaited with suspense the announcement of the survivors and the listing of Buchanan as one of the men on board brought a personal interest never before experienced by the town in the war. Until last week the borough had done its war bit in a sort of impersonal manner but the sinking of the *Tuscania* brought the war to the heart of the town with a suddenness that was marked by the intense interest displayed in the welfare of the county's only representative on the ship.

When the news of the safety of the young man was flashed from Phila. to the office of W. J. McCarthy here the news spread like wild fire and the family was overwhelmed with congratulations. The parents were overjoyed after the hours of suspense caused by the inability to get any definite information regarding the survivors.

Buchanan was widely known throughout the borough and the popularity of the young fellow was evidenced in the interest taken in his welfare. St. Clair is proud of the fact that it was represented on the ship without having to go through the horrors of having to record the death of one of the two hundred and odd boys that are in the service of the country from that borough and it is needless to state that the experience of the Buchanan family was taken over by the people of the town as one in common that is being borne with a general feeling of gladness and relief throughout the whole town.

LETTERS FROM A TUSCANIA SURVIVOR

Two letters have been received by Mr. and Mrs. John Buchanan from their son John who was one of the survivors of the Tuscania and is now in France. The letters are as follows:

Sunday, Feb. 10, 2:45 p. m.

Dear Parents: This is the first time I have had a chance to write you because it will go for nothing. We were wonderfully blessed in being saved and I feel that you must have thanked God many a time because I have. I must confess that I was excited at first but after 10 or more minutes I was cool and in those 10 minutes I seen the effects of getting excited. I could tell you many a story that sure would effect you but such is the fate of the war. I am sending you a clipping from the paper which isn't much but no doubt by this time the papers at home are full of it which no doubt at caused the people to wake up.

Since we have landed at the southern end of Ireland we have been eating and enjoying the kindness of the Irish people.

I was on the boat 1 hour and 15 minutes after being hit. Mother I shall never forget that shock. It meant a great deal for some time after I was nervous from a headache.

At present we are in a rest camp and I presume will be until they get us out. You can imagine the way we looked as we marched through Ireland. I was lucky enough to come through with an overcoat but I left a fellow have it who was without one, however at present I have it back. Unless we get paid I am without any toilet articles. We have 1-2 cake of yellow soap and a towel between three of us. So you can send me a tooth brush and cover to keep it in. This is a case of some kind so I can carry it in without getting dirty.

Remember when we used to say eat the potatoes skins and all, well I never thought I would land in such a place and especially so at the time we did "midnight".

After two days running around we were settled for a night during those hours the band gave us a concert which every one enjoyed.

The next day we were given a supply of clothing. I had a pair of Irish boots given me because my shoes were worn clean through.

I have written a postal card to Aunt Kate and will mail it with yours. We have to stay in the barracks so when I finish yours I will write to Mrs. Davis.

I really do not know anything much to tell you because I dare not say anything about our trip across the Atlantic. I can tell you this however that I wouldn't buy any fish that came from the Atlantic Ocean because if you do you may eat part of your son. I fed every fish in the ocean a good fat meal at that.

I never did mind the trip from New York to Halifax but from Monday on I sure was sick. We left Halifax on Sunday afternoon Jan.—and on Monday morning I was sick. From then on I didn't care if I died or not.

When we were coming in here this morning I noticed a good many horses and guns and some field artillery then I wondered if Carl was there and as soon as I can I am going to see if he is in camp.

Since we were torpedoed I have made a three hour run across the English Channel and that was last night We left at 9 p. m. and arrived in England at midnight Then from there we can to London arriving at 6:40 a. m. When were laying over at Belfast a man from the states I cannot tell his name came over at the same time as Charles did and he told me about the journey. Which was very successful but it took a great deal of dodging to get through.

Just came back from having a suit of underwear and a change of socks issued to us so tomorrow me for a decent bath.

Am writing from here in the Y. M. C. A. and it sure is a wonderful place. I presume that we will have some kind of services after a while. In our hut, that is what we call the barracks) the Y. secretary held a short service after which they gave us an apple "came from America too."

Remember Mother of me telling you about Gillespie and I sent his picture home. He is among the missing and according to one of the boys that were brought in today he and three more were in a life boat and were washed upon the rocks. After that no one seems to have heard of him. I also lost one more of my squad I had in Texas and that was Snooks who came from around Harrisburg. I sure have missed quite a number of my old chums. The squad I have at present was very lucky, so far I can count for all but one and he comes from Ohio. Red Moore we called him.

I also seen the result of the explosion in Halifax harbor, a terrible thing it was and as we were there one day I could plainly see the result.

On the way over the sea was extremely choppy and the weather cold. It was a very good thing the Huns didn't get us the night before or else it would be a very different story to tell. But then Mother we must be thankful to Him who has heard my prayers and has saved me. Out of the depth of my soul have I cried and Thou hast heard me O God."

Everybody is busy writing home or somewhere else and as I must get some more paper I fear I shall lose my place at the writing table.

This part I send you of the torpedoing of the ship you can show to Mrs. Davis if you will because you are the only one to have it.

If I can I am going to write to all of my aunts and the rest of them I will write you at least two a week or more. So far we can write as many letters as possible but they tell me at France you write just so many and that is all. Once a week we get a blue envelope and in that you can write as many as possible. That is what the boys told me while we were in Ireland, at present we will be

Today the Lieutenant took those who wanted to go to church down to the city but as it is three miles away and I have not very clean clothes I didn't go however I am not missing anything for we are having services right now in the Y. M. C. A. also the secretary is a regular preacher and is a good one at that. He has charge of the spiritual work in the hut every night after the evening's entertainment, he always dismisses us with a prayer and short talk.

On Friday afternoon we signed the pay roll that advances us \$10 in English money. After signing this the officers marched us to town and was entertained by a vaudeville and movie show. Then we marched back and had supper, after which we were paid. This was 7 p. m. and of course I was too late to send the cable-

here for quite a while because of our equipment. I spent all my money buying soap, tooth powder and brushes, in America and now they are gone and I am busted. So if you will send me a tooth brush, powder and soap I will be able to get along for a while.

Well mother I must close now and I will write you on Wednesday and Sunday and then in between times. It will be sort of a chat. Lots of love to all and wishing to be remembered I close with a great big kiss for you, Dad and the rest of you. Most affectionate son John.

Dearest Parents and Brothers:

Good morning everybody for I guess at least Dad is up putting the fish on the stove, I only wish you could have shared with me in my breakfast this morning. I came out of the dining hall and crossed to my hut or barracks and toasted my bread and fried the bacon. Then with butter and toast I sure did have a dandy meal.

gram to you but yesterday morning I sent it to you. It was cabled or rather will be cabled from London tonight and you have it tomorrow before I will have supper.

Today is fine out just enough snap in the weather to keep you a moving.

Perhaps you will have the chance to see us in the movie pictures. We were taken about a dozen times or more, both marching and standing still. Perhaps they won't be realized for some time to come.

I sure did have some feed after being paid. Salmon, Cocoa, cakes for you can't buy bread except at certain times felt 100 per cent better.

Well mother I sure did enjoy the services and I am sure you would have more are great. Perhaps I will have more news to tell you this afternoon so I will close at this time.

All I can say is our dinner was good and thoroughly enjoyed. This morning at the Y I met a fellow from Lansford who was conductor on the trolley line from around Pottsville. He knew some of the fellows from St. Clair, also Bob Michaels from Centralia. He lived within a block from Bob at Lansford. No more news this time mother. Looking forward to receiving mail from you within a month. Lots of love to all and best wishes for the rest. John, Your affectionate son.

TUSCANIA BOYS STILL IN ENGLAND

The survivors of the Tuscania are still in England, according to John Buchanan, who was on the torpedoed ship. Buchanan in his last letter home speaks interestingly of the sights of London which he visited, the camp being within a few miles of that city. The letter is as follows:

Dearest Dad and Mother:—What joy I had this morning when I went down for the mail. Can you imagine me receiving 21 letters? Well I did and, oh my, how I did read them. I cannot find time up to the present to re-read them and as I answer them I will read them over. I also had a package containing a bible from Virgie and a tooth brush holder with a small tube of Colgate tooth paste in it.

I will answer the letters on the installment plan that is, I will begin telling you of my trip to London, and as you have begun to receive my mail it will continue to come for I have written you every week.

I left here for London on Sunday aft-

I left here for London on Sunday afternoon—in company with another boy (Shapiro by name, who I have told you about) and arrived in London in the evening, going straight to the American Y. M. C. A. or the "Eagle Hut" where we put up at. We first engaged our beds and checked our overcoats, washed up and started out to see the place. In so doing we came to the railroad station and, seeing a crowd around who were waving their handkerchiefs in the air and frisking about as if excitement prevailed. Of course we went to see the cause of the trouble and this is what we saw.

Ambulances driving up to the train receiving their eight patients and immediately start off for the hospitals. Victims of the great struggle that is raging. As they passed away another one would take its place and so on the ambulances moved between two lines of people, who eagerly gazed with anxious and trembling eyes and hearts to find out if their loved ones were among them. The silence that rested on the crowd spoke more and meant more than any great display of cheering. But, mother, it would not pay for us to be pessimistic and so with a few expressions of sympathy we pass on to the brighter side of life, and once more our hearts are gay and cheerful.

I could just imagine what it meant to the people of London to witness the first air raid that the Huns made, and what it means now. I heard quite a few stories of their cruelty that are not published in order that Fritz won't know the damage.

Well we walked around until 10:30 p. m. or so, and made our way back to the Hut and went to bed. Yes, I really enjoyed it; felt just like home, and right here, mother dear, remember that you never need worry about me when I am in the city of London, for the Y. M. C. A. will always be my home. Arose about 7:30 a. m. Monday morning and enjoyed a wonderful shower bath, stayed under for 30 minutes or more and then proceeded to the dining hall for breakfast. Being on pass of course we were entitled to ration meals and extra. Breakfast consisted of bacon, eggs, potatoes, oat meal, and an orange, cup of cocoa and a piece of bread, costing about 25c each. After breakfast I went down to the bank but it would not be opened until 10 a. m. In this I was very much disappointed for I wanted to take the sight seeing tour in that left the Eagle Hut at 10. However we wandered around Piccadilly and Trafalgar Square getting back to the bank at 10:15. I had no trouble at all in getting the money and I certainly want to thank you mother for sending it to me. I can assure you, it was very much appreciated and spent with the spirit of getting what I absolutely needed.

Coming from the bank we decided to visit the famous war painting of the Grafton Galleries. Wonderful is no word for it, why they were simply great. As I cannot even begin to tell you

about them I am sending home the booklets I purchased and you can study them and keep them for me. We spent an hour or so in here but it wasn't long enough and my next trip to London whenever it will be, I am again going to visit them. Perchance our Lieut. will not pass them but I am going to try and if not I will keep them with me.

From here we walked down to the street in London that correspond or is supposed to correspond with Fifth Ave., New York City. Why it is a shame to even think of it as such. Regent St. is the name, but goodness, it is nothing.

Continuing our walk we came back to the Hut and had dinner. Dinner consisted of potatoes, cabbage, ham, cocoa, custard and black berry bread, that is bread made from white flower with blackberry jam on top. I went into the musical and recreation room and rested

awhile, while the other boy finished his letter. Then we started for the afternoon part of the program, making our way to West Minister Abbey. Services were conducted and that delayed us for an hour or two.

We wandered down to the House of Commons and House of Lords, and among the gardens by the side of the river Thames, going back to the Abbey where we saw the ancient places of the famous men of England and their resting places. Far too numerous are they to mention. We begin the journey back to the Y and saw many trophies that were captured by the Canadians from the Germans.

We washed up and had supper consisting of two eggs, fried onions, potatoes, honey bread and cocoa. I am coming to the best part of our journey now. After supper we attend the concert and leave at 8:30 to catch the train back for camp.

We got the train to B— G— and waited for the bus to take us the rest of the distance, and after a 30 minute wait we inquired and learned the last one left at 8:20 p. m. Can you imagine us then, tired with walking and having to walk as we thought back to camp. However, by asking a "Bobby" or as you would call him a cop or policeman, we were directed to a "Tramp" that took us to B—, seven miles from camp. I forgot to explain what a "Tramp" is. In our country it is an electric car. Any way we got to B—about 11:30 p. m. and here is the best part of our trip "we begin to walk back to camp."

I have my binoculars and my pocket

I have my big over coat and my pockets full so altogether I was carrying some 20 or 25 lbs. more than what "Sappy" was or Shapiro. You see, mother, the names are familiar so here after if I mention Sappy you know I mean Shapiro. Going was alright for a mile or two then by this time Sappy was falling behind. I set the pace and made him keep to it, much to his disgust. I myself wasn't very much better than he was yet as an N. C. I was to set an example.

We passed quite a few hay stacks, and Sappy wanted to put up at the "Knights of the Road's Inn" but I was for going on. About five miles was passed when I surely thought I would have to give in but I kept on and arrived in camp this morning about 2:30 tired and ready for bed. I found a great deal of amusement and fun however in having Sappy continually begging then finally wishing I would have to give up. As a Jew of course he is naturally funny and many a laugh I have.

The Y. M. C. A. is situated on the strand and has sleeping accommodations for a great number. In our dormitory they were 200 beds with a chair by the side of each bed and nice covers and clean bed clothes for the bed. As they are not issuing any more passes from France to England for the soldiers, the sleeping accommodations were not so bad. In our dormitory they were probably 100 or more fellows including Canadians and ourselves.

More than half of the women employ-
 es are from the states and we can talk
 to them and they to us like brothers and
 sisters. I was talk'ng to a woman from
 Phila. who waited on us, and say may-
 be it doesn't do one good to see and be
 able to talk to our own good American
 girls. Just like America once again. I
 cannot say enough about the Y. M. C.
 A. and I am sure that only those who
 are "over here" can only appreciate
 what it means. It is a fact and one
 that has to be recognized that the Red
 Cross is a saviour of lives while the
 Red Triangle or Y. M. C. A. is a saviour
 of reputations and characters.

Today it has rained but I must go
 up to the hospital with a few letters for
 one of the boys who is confined there.

As this is the first mail since being
 here I know what it is to hear from
 home and the sweetheart, as I know
 he has one, for I have three letters
 from the same girl. But there I must
 not give secrets away.

This letter is only a mention of my
 trip to London and I must hurry on. I
 will answer the others from now on be-
 ginning tonight.

Best wishes and lots of love for all of
 you. Don't worry about me, for I am
 better than ever. Dr. says I am getting
 too fat and recommends me for a trip
 to America. Now what do you think of
 that

James 'Doc Jim' Buchanan, 88, longtime pharmacist in East Falls

He grew up poor in the coal country, leaving high school for the mines, but Jimmy Buchanan managed to get himself through college. Then he helped two young brothers get there. And after he married, he sent all three of his children.

"A man cannot leave a better legacy to the world than a well-educated family," Mr. Buchanan liked to say.

And as much as anything else, that indeed became the legacy of James W. Buchanan's life, those close to him said after he died Monday at his East Falls home of nearly 60 years.

But it was not the only way Mr. Buchanan, 88, made his mark.

Thin and white-haired, an engaging man with a light humor, Mr. Buchanan was known as "Jimmy" or more often "Doc Jim" — the corner pharmacist with a easy smile who knew people's names, who helped folks in trouble.

His East Falls drugstore was a place for more than aspirin.

The storefront shop, in a three-

And when he had saved enough money to start his own store, it was in East Falls where he looked. In 1929, he opened Buchanan's Pharma-

Falls who feel that Jim Buchanan was a special uncle to them. He really took an interest and cared," said his daughter, Cindy B. Taylor.

In fact, his drug store — with its soda fountain, its Santa scenes at Christmas, its shelves neatly lined with jars and bottles of all kinds — became something of an institution.

People came not only to fill doctors' prescriptions, but for an ice cream soda, a bottle of cologne, a small brown paper bag of penny candy.

The sick and elderly received free deliveries. People short on money still had tabs running for years. His family helped him run the store, which sat underneath their upper-level home.

Among his customers during his 47 years in business, his family said, was the Kelly family, to whom Mr. Buchanan delivered personally — at the front door.

"Other delivery people had to use the back door," said his son William. "But with him, the maid would come to the door and say, 'Hi, how are you, Doc Jim?'"

story, red-brick rowhouse at Indian Queen Lane and Vaux Street, had since 1929 also featured Mr. Buchanan's special way of doing business, of being both pharmacist and father.

It was to him whom families had twice run when expectant mothers were ready to deliver their babies. It was at his store that many a neighborhood boy had found his first job, that people often stopped just to talk.

"He was just like family with people in East Falls," said a neighbor, Marie Rutherford. "He would laugh with you and he would cry with you. He would just feel for you, I guess. I always say he's a legend."

"He was just a remarkable person, full of life and fun, a beautiful person," Rutherford said. "He was always caring for everybody in the neighborhood. If you said 'Jim Buchanan,' I don't think there's anybody in East Falls who would say, 'Who was he?'"

Born in Centralia and reared in St. Clair — the son of a tinsmith in a family of nine — Mr. Buchanan took a job in the coal mines to help his parents. Four of his brothers served in World War I. Times were lean.

After the war's end, in the early 1920s, Mr. Buchanan was able to pursue his own education — a dream he had never lost sight of. He moved to Philadelphia and in 1924 graduated from the Philadelphia College of Pharmacy and Science.

He found his first job at a pharmacy in East Falls.

1929, he opened Buchanan's Pharmacy. A month later, the stock market crashed.

But Mr. Buchanan survived it. Not only that, he went on to help his two younger brothers get through school, including Ralph, who became a prominent New Jersey doctor.

He also gave his encouragement to students at what was then Woman's Medical College, now the Medical College of Pennsylvania, about a block away from his store. He made sandwiches for them, underscored the importance of education.

And at 37 years old, Mr. Buchanan married one of the medical students, the former Helen Brown.

Together the couple ran the pharmacy and started a family. They saved money. Mr. Buchanan worked seven days a week, 12 to 13 hours a day. He wanted his children to have the best.

All three children went to private schools, then to college. One later went to medical school, another to earn two master's degrees.

"He sacrificed an awful lot for his kids," said a son, Dr. James R. "He placed a tremendous emphasis on education. . . . He was a guy who came out of the coal region, who made something out of himself by working real hard, and then passed that on to his kids."

In the process, Mr. Buchanan touched more than his family.

"There are a lot of people in East

After Mr. Buchanan retired and closed the store in 1976, he still walked around the old neighborhood a lot, a cane in one hand and the leash for his dog in the other. Still, he could see those he knew from surprising distances and he would raise the cane and wave.

When he was too sick to go out he would wave from the front door.

"He had a smile for everybody and knew everybody by name," said Rutherford, his neighbor. "He was known for being friendly."

"You know that song, 'Leader of the Band'? I sent him that one year for his birthday. That's the way he was. He was an inspiration to us, and he left us quite a legacy," said his son William.

He is survived by his wife of 51 years, Helen Brown Buchanan; two sons, Dr. James R. and William M.; a daughter, Cindy B. Taylor, and 12 grandchildren.

Dr. Ralph McKay LaShelle Buchanan, 72, of 515 Fairbanks St., Phillipsburg, a practicing physician in Phillipsburg since 1936, died Thursday in Warren Hospital. He and his wife, Grace (Albinson) Buchanan, celebrated their 42nd wedding anniversary Sept. 23.

He was named chief of staff at Warren Hospital in 1961 and became emeritus chief of staff in 1972. He continued practicing at 8 Market St., Phillipsburg, until this month.

Licensed to practice in New Jersey and Pennsylvania, he was the only physician to serve simultaneously as president of New Jersey Medical Society, the state's board of medical examiners and the New Jersey Industrial Medical Society.
