

#### TUSCANIA SURVIVORS REUNITED ABROAD

T HE American Lumberman of June 15, published the following interesting story:

"When the ill fated Tuscania sailed from the American shore early last February it had on board 800 lads recruited from the woods, sawmills and lumber yards of the country as well as several hundred soldier boys. Most of the boys were fortunate enough to be among the saved, following the 'U' boat attack off the eastern coast of Ireland, and were landed after hours of suffering and mental torture at different points in the Emerald Isle and Scotland. The forestry lads who survived the souri, in responsible positions, one by one congregated at Morning Hill Camp near Winchester, England.

"Before they departed for France the boys had a group photo taken; an enlargement of it was received this week at the offices of the Long-Bell Lumber Company, in Kansas City. It will be recalled that 164 of the Tuxcania dead, many of whom were forestry lads, now lie buried near Port Ellen, Islay Island, one of the Hebrides group, but all the Long-Bell boys were among the saved and each one is now doing his 'bit' in France.

This was especially true of those whose loved ones' names did not appear in the first list of 1,000 survivors sent out from Washington Saturday. Among these were the wives of First Lieut. Charles L. Samson of 6730 Perry avenue and William E. Barwick of 3334 Fulton street.

#### Telegrams Arrive.

Dawn yesterday found them still waiting. It was well toward sunset when each received a telegram:

"McCain, Adjt. Gen."

There were hundreds of telegrams like that delivered yesterday.

## THE LATEST NEWS CONCERNING THE SINKING OF THE "TUSCANIA" AND THE PROBABLE SURVIVORS THEREON.

We have received, within an hour of going to press with this edition of the LUMBER WORLD REVIEW, on Friday, February 8, a telegram of considerable length from Lynn M. Lamm, in charge of the Washington Bureau of the LUMBER WORLD REVIEW, District National Bank building, Washington, D. C., which telegram gives the most authoritative news which we will likely receive for several days concerning the personnel of the officers and the names of those who sailed upon the ill-fated transport:

Washington, D. C., February 8.—
[SPECIAL TELEGRAM.]—Nothing has been heard from Dewitt S. Schwartz, of St. Louis. This means nothing, because the War Department has nothing definite on individuals. He sailed on the Tuscania, as the records show.

At this time it looks as though very few members of the Sixth Battalion lost their lives when the Tuscania was torpedoed. Official reports to the war department state that less than 100 soldiers were lost. Of this number many were detached, as evidenced by the fact that bodies are being washed ashore with identification tags, but no units shown. This could not be the case with the lumbermen, because all had been attached to some units before sailing. In addition to the men drowned or killed when the Tuscania was torpedoed, it is now reported that more than 100 men are in hospitals. The reports show nothing as to the seriousness of their cases.

Officials of the War Department state that the only way they will be able to learn the men actually lost will be to make a complete list of those saved and compare that with those known to have sailed on the transport. This is necessary, because many of the dead cannot be identified.

It is estimated that several days will elapse anyhow before any authoritative list can be completed.

Major Benjamin F. Wade was the commanding officer of the Sixth Battalion when the Tuscania sailed for Europe. Other officers known to have sailed, taken from the official list of the War Department, follows:

Company D—Captain D. D. Hall, First Lieutenant L. S. Saunders, First Lieutenant Milton Pittman, Second Lieutenant H. C. Walcott and Second Lieutenant C. R. Beal.

Company E—Captain J. Edward Gillouly, First Lieutenant Chas. A. Schweisinger, Jr., First Lieutenant Benton L. Yost, Second Lieutenant Warren Richard and Second Lieutenant Jorden Richard.

Company F-Captain Charles E. Hetrick, First Lieutenant Arthur L. Chamberlain, First Lieutenant, William C. Buhmann, Second Lieutenant Frank Mizell, and Second Lieutenant Daniel W. Parker.

A number of the above named officers have already been reported saved, but definite information at this time is tacking at the War Department.

[Seth E. Barwick, Chicago representative of the Long-Bell Lumber Co., of Kansas City, whose son, William E. Barwick, is with Company F, Sixth Battalion, Twentieth Engineers (Forest) and sailed on the Tuscania, told the Lumber World Review late on Friday that he had up to that hour had no word from the young man.—EDITOR.]

#### FROM TWO TUSCANIA SURVIVORS.

Letters from Americans who have joined the overseas forces are always of interest, but a letter from a lumberman who was on the ill-fated Tuscania and who escaped unscathed cannot but be of surpassing interest, to not only his immediate friends, but to members of the trade generally. Will Barwick, son of Seth E. Barwick, of the Long-Bell Lumber Company, Lumber Exchange, Chicago, was not heard from for several days after the disaster occurred and much anxiety was felt by not only his parents, but by many of his warm friends in the trade as to his fate. However, on the third day after the sinking a cablegram got through announcing that he was safe. As soon as Mr. Barwick was able to find writing facilities he advised his parents from England as follows:

"I hope you received my cable in time to keep you from worrying greatly. I know that you must have known that I was somewhere on the ocean when the accident occurred, and, of course, could imagine the worst in an instance of this sort. I tried my best to cable you at an earlier date, but it was impossible owing to the fact that the telegraph authorities seemed to be under the impression that it would not be permissible, and it took two or three days to get it straightened out. I can imagine the excitement and anxiety of those who had reason to suppose their relatives or friends might be on board, and feel sorry that they had occasion to worry about us.

"Slighting all descriptions of the accident, I will say that I only suffered two losses, my tobacco, of which I had a good supply, and my fountain pen. I am now located in England with the balance of the boys and we are being treated just fine—a very comfortable bed and quarters and the feed is very good.

"I have had the opportunity of seeing a great deal of the country here, and had it not been for the accident and the knowledge that some of our friends were lost on the boat, it would have been enjoyable beyond words; but under the circumstances we could not take a great deal of pleasure out of our trip across the country to our present quarters. The spirits of the boys are reviving rapidly now, however, and as the government was kind enough to advance them some money yesterday, they are nearly in a jubilant state.

"There were four of us boys working in the office together before we left the states, and we lost one of the very finest when the accident occurred He was living and working with us every day and we got to know him very well, so we feel his loss most keenly.

"I cannot speak highly enough of our treatment by the Red Cross and the English people since the accident occurred, for they have evidently given up everything to our comfort and convenience, and I am very glad and proud of the fact that mother is doing so much to help that organization. Any scandal monger or pro-German who quustions the good work, or where the money goes to, of either the Red Cross or the Y. M. C. A., does not know of what they speak and deserves a severe reprimand. The Red Cross is unquestionably for the soldiers' welfare and the Y. M. C. A. is everything outside of his routine of camp life.

"We have often questioned the motives of our American people who are always running off to England to travel, but from what I have seen of Furni conditions we can hardly blame them so long as they remain loyal Americans. Some of the old pictures I have seen and travel talks that I have heard of England I have now had a chance to see in real life, and if I were now in civilian life and could putter in and around some of these quaint old places, it would be a most enjoyable experience to me, but under the circumstances I cannot find so much enjoyment in it outside of the educational feature.

Letter written from England, hoping his family had received his cable in time to keep from worrying greatly. The telegram authorities said it was not permissible to contact home, so he had to work for 2 to 3 days to get a cable sent. He suffered two losses: his tobacco (now with a good supply) & his fountain pen. He is in England now with most of the boys, and they are treated fine, have comfortable beds & quarters & good food. He has seen some of the country & it has been enjoyable except for the accident (the Tuscania) & the loss of some friends. The spirits are reviving among the boys, particularly after the government advanced them money yesterday. Four boys in his office were always together, and they have lost one of their finest, who was living & working with them daily. The Red Cross & English people have provided much, and feels proud that his mother is working for the Red Cross. Anyone who questions the Red Cross or YMCA doesn't know what he's talking about. People have always wondered why travelers visit England, and if a civilian he would find it most enjoyable.

Edna H. Barwick, 99, of 1209 21st Ave., Rock Island, died Saturday, Aug. 21, 1993, at Silver Cross Nursing Center, Rock Island. Memorial services are 1 p.m. Tuesday at Wheelan Funeral Home, Rock Island. The body was cremated. Entombment is in Oakdale Memorial Gardens Mausoleum, Davenport. Memorials may be made to Friendship Manor, Rock Island, Intouch Of Lutheran Social Service of Illinois, or First United Methodist Church, Rock Island. The former Edna H. Howarth was born Sept. 4, 1893, in Chilton, Wis., the duaghter of Joseph and Abigail Castona Howarth. She married William E. Barwick in 1921, in Seattle, Wash. Mrs. Barwick attended Oshkosh State Teachers College and was graduated from San Francisco State Teachers College. She received her masters of arts degree from the University of Iowa.

She began teaching in Rock Island in 1929, previously teaching in Stockbridge, Wis., Oak Park, III., San Antonio, Texas, and Seattle, Wash. Her first position in Rock Island was at the old Horace Mann School on 14th Avenue and 36th and 37th Streets. The next year she was transferred to Denkmann, which was then a new school.

In 1935 she became principal of Hawthorne, teaching there half days until the second semester when she was named principal of Irving as well. From 1936 to 1943 she served both Irving and Grant schools. In later years she was appointed to Audubon and divided her time with Grant school until 1946, and then with Denkmann until 1952. She continued to be at Audubon until her retirement in May of 1964.

She was past president and a charter member of Mu Chapter, Delta Kappa Gamma and was affiliated with Chapter BK, PEO Sisterhood and Amelia Trenkenschuh Branch, Association for Childhood Education. She was a board member and former vice president of Rock Island/Moline Branch American Association of University Women and belonged to two of its study groups, Reviewers and International Relations and was a former member of Jane Delano Circle of Kings Daughters. She enjoyed reading, playing cards and gardening. Survivors include a daughter-in-law, Bette G. Barwick, Rock Island; a grandson, William E. Barwick, Phoenix, Ariz., two stepgrandsons, Terry Tellefson, Rock Island, and Dean Tellefson, Aurora, Colo.; 3 stepgreat-grandchildren; a sister, Esther Howarth, Rockford, Ill.; and a nephew. A son, William E. Barwick died July 4.




