Conspiracy On Part Of Juror Being Charged

**Affidavits Claim Jury Was
Tampered With In The
Sullivan - O'Leary Case
At Milwaukee**

Milwaukee. — (UP) — Affidavits charging that the jury which found them guilty of conspiracy in illegally settling the claims of war veteran was tampered with, were prepared for filing in federal court here today by Attorney Henry F. Sullivan and John F. L. O'Leary, former regional adjudication officer of the Veterans' Bureau.

Federal Judge F. A. Geiger ordered a stay of execution of judgment in the case.

The men were found guilty last week and each was sentenced to serve a year in the house of correction and fined \$500. Sullivan charged today that Frank M. Bayliss, one of the jurors, had sworn to an affidavit that during the trial he was approached by a man who posed as a secret service agent and that the "agent" told him his compensation as a disabled veteran would be stopped if Sullivan and O'Leary were acquitted.

Roy Willequette, 24, the man who Bayliss accused of approaching him during the trial, was ordered sent to a hospital for observation. Police said he had a correspondence school detective's badge.

A writ of supersedeas, granting them the right to be heard on an appeal, was filed in Chicago Saturday and if a new trial is denied them here Sullivan said he would offer the supersedeas, staying action in the case pending. To appeal this, it was pointed out, probably would delay any further action until next October at least.

Milwaukee. — Charges of jury tampering were to be laid before Federal Judge F. A. Geiger today when John F. L. O'Leary, former regional adjudication officer of the United States Veterans' bureau here, and Henry J. Sullivan, Milwaukee attorney, were to file a writ of supersedeas granted by the Circuit Court of Appeals in Chicago on Saturday.

The writ grants O'Leary and Sullivan a stay of execution of judgment and sentence passed last week. The two defendants were found guilty of conspiring to accept bribes in connection with the claim of William Morrell, a veteran, and were sentenced to one year in

the house of correction and a fine of 500 each by Judge Geiger.

Arrest Made

According to affidavits which the two men say they will present to the court on Monday morning, one of the jurors who voted for conviction, Frank W. Bayliss, 990 Fifty-sixth street, was approached while sitting on the jury by a man who told him he was a secret service agent from Waukegan, and told that unless a conviction was obtained Bayliss' compensation would be cut off. Bayliss is a disabled veteran.

Sunday afternoon Roy Willequette, 24, of 198 Thirteenth street, was arrested upon complaint of Bayliss that he had posed as a secret service agent. The man was locked up in central police station. He was recognized by Bayliss, according to the police report, following an automobile accident at Thirteenth and Wells streets.

The affidavit will state, it was said, that the fake agent approached the juror and displayed a badge purporting to be that of the secret service department; that he threatened to get Bayliss in trouble unless Sullivan and O'Leary were convicted; that upon hearing this threat the juror was influenced in his findings.

To Ask New Trial

The writ of supersedeas, however, was granted by Judge Samuel Alschuler of the District Court of Appeals, Chicago, on the grounds that a confession, alleged to have been made by O'Leary was improperly admitted and that an error might have been committed in the attempted exclusion of former service men from the jury, according to the two defendants.

The jury tampering charges have not been divulged, it was said. The arrest of Willequette Sunday night brought the additional charges from the two men. The affidavit, they pointed out, was obtained several days before the man was arrested.

Since the opening of the first trial, more than two weeks ago, the defendants have been promising sensational disclosures. They will request a new trial before Judge Geiger, and in the event the request is granted, have promised to present additional evidence of a startling nature.

The cases against Sullivan and O'Leary went to trial in federal court on July 7. On that date Judge Geiger dismissed the individual indictment against Sullivan, charging that he bribed O'Leary. The individual indictment against O'Leary was passed and may or may not be pressed in the future.

Get Sentence

The conspiracy case against the two defendants went to trial the same afternoon. On Jan. 8, O'Leary confessed to pressing the claim of William Morrell, war veteran, for \$2,461, using the influence of his official position, and to accepting \$550 as his "cut." Later in the trial he repudiated this confession, claiming the \$550 was given by Sullivan in payment of a debt to O'Leary.

Late in the afternoon of Jan. 8 the jury took the case, deliberating until the next morning, when a disagreement was declared and a new trial ordered. During the first trial Levi H. Bancroft, federal prosecutor, elicited the information from O'Leary that the name the defendant formerly used, as his right name, was John Francis Latko, and that he was Polish, not Irish.

On Jan. 14 the second trial of the conspiracy defendants began. It closed with their conviction and on Jan. 15, last Wednesday, Judge Geiger sentenced Sullivan and O'Leary each to one year in the house of correction and fined each \$500. A five-day stay of execution was granted, ending Monday morning.

Thirty-nine liquor cases of minor importance remain on the federal court calendar. Interest is centering on the trial of Erwin F. C. Voelz, former manager of the savings department of the National Bank of Commerce, indicted on charges of embezzling \$216,000. Voelz is named in four indictments involving Charles J. Fox, Milwaukee theatre man; Charles J. Burkhardt, Charles Schipper, and Louis H. Frank.

Trial of the embezzlement cases is scheduled for Wednesday.

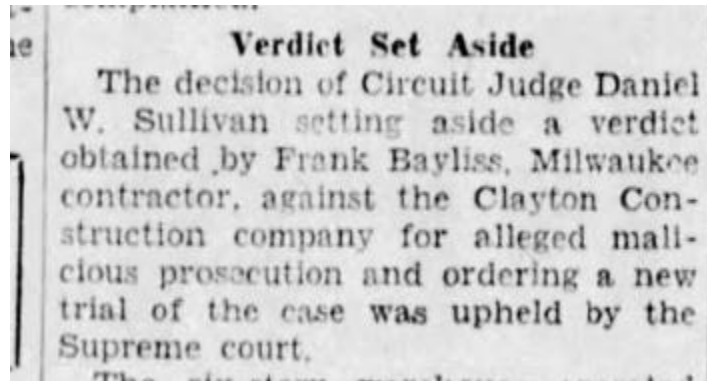
Henry J. Sullivan, Milwaukee attorney, and John F. O'Leary, former regional officer of the veterans bureau, convicted of bribery and sentenced to a year's imprisonment, presented an affidavit to the court Saturday in support of their motion for a new trial.

The affidavit was signed by Frank W. Bayliss, a juror in their trial. It stated that a man representing himself as a secret service operative had approached the juror during the trial and warned him that war veteran's compensation which the juror was receiving would be terminated unless he voted "guilty."

After this sworn statement had been presented to the court, E. J. Koelzer, assistant federal district attorney, countered with another from the same man, swearing that he was drunk when he signed the first one in company with Sullivan.

Judge Geiger continued the case.

Sons of St. George Like Old British Custom of Having Beer

The resolutions to exclude liquor from buildings in which lodge meetings of the Sons of St. George are held will probably be turned down at the annual meeting of the grand lodge of the Illinois jurisdiction in Milwaukee on Aug. 11, 12 and 13, or adopted amended so as to exclude liquor only from the lodge hall during the sessions of the lodge.

Acorn lodge, which had instructed its delegates to vote against the resolution, has agreed to support it in the amended form.

"A custom brought here from England of having beer at the lodge sessions is what is principally aimed at," said J. A. Bayliss, secretary of Acorn lodge, Milwaukee. "If members of the lodge want to have a jollification meeting after the session is closed we see no objection, and Acorn lodge will oppose any attempt to deprive members of this privilege."

The entertainment program for the meeting of the grand lodge was completed last night. It includes a smoker at Blatz hotel on Tuesday night, a trolley ride to Whitefish Bay on Wednesday night and degree work and a jollification meeting at the lodge hall, Third and State streets, on Thursday night.

The Blatz hotel will be headquarters for the grand lodge and the sessions of the meeting will be held in the assembly hall in the Shubert theater building.

Papers Not Accepted.

Milwaukee, Wis., Aug. 10.—The nomination papers of John A. Bayliss, republican candidate for county clerk, have not been accepted by County Clerk Phelps, because of defective signatures.

Of the 1,072 signatures handed in by Mr. Bayliss at 6 p. m. Saturday, it is found that nearly two-thirds are defective.

Upon the advice of Assistant District Attorney Norman L. Baker, these have been thrown out. The signatures remaining are not sufficient for nomination.

Be Investigated.**

Milwaukee, May 6.—There is going to be about the liveliest meeting of the year at the Merchants and Manufacturers' hall, Germania building, Wednesday night, when the Housewives' league and the Retail Market Men's association will settle their long distance argument as to who is responsible for the high cost of living in Milwaukee.

The housewives, a few weeks ago declared that Milwaukee market men are charging more for meat than is charged in other cities. The accused have entered unqualified denial. Final arrangements for the market men's "trial" have been arranged between Mrs. Frank Van Ness representing the housewives, and John A. Bayliss for the market men.

The Citizen's Business league, Federated Trades' council, City club, Milwaukee association and Merchants and Manufacturers' association have each designated a member to act as jurors to hear the evidence.

Duty to Keep Clear.

John A. Bayliss, prominent member of the English-Americans in Milwaukee, agrees with Mr. Regan:

"It is the first duty of the administration to keep clear of war when it can be done with dignity. It is up to the administration to do all it can to keep us safely at peace with the world. A policy of interference in this war would lay us open to serious entanglements.

"It is perfectly right to allow the warring nations to decide what is and what is not contraband and have the fight out among themselves. It is foolish to talk of loss of dignity. The world knows that we are a great and strong nation and that if we wished we may absolutely dominate the seas with our navy. The great navies are too busy hunting each other to take serious notice of us. The Bryan letter is an act of strength rather than anything else."

J. A. Bayliss, Milwaukee, representing the Milwaukee Retail Marketmen's association, said that the trouble was that people were living beyond their means and that the lowering of the exemption would make them more careful. To The Journal: As a taxpayer of the state I want to protest again against the expenditure of \$3,000,000 of state funds for La Follette's memorial. And if ever it passes I will get an injunction against it if I have to go to the United States supreme court.

Playing politics to gain the votes of those in sympathy with the enemy in war time is something that calls for a rope, not a memorial. Let the state put up their memorials at a million each for our boys who fell in the war, one in Madison, one in Milwaukee and one in the western part of the state.

La Follette's words were played up big in Germany and heartened the foe, raised their morale, made them think there was a chance of a split here, caused many a death on our side and on their side, prolonging the war.

It was natural for Germany to make the most of La Follette's utterances to justify her own side. This worked against us as the words of no other man of any other nation could, because the Germans knew full well America was the deciding factor.

The letter referred to by F. A. Towne, which appeared in the Daily Telegram is as follows:

I have before me a clipping from the Telegram containing a letter written by J. A. Bayliss and published at the request of Capt. Henry. In this letter Bayliss attempts to brand the late Senator La Follette as a traitor to his country, and undeserving a monument.

If Mr Bayliss is so fortunate as to live until the unbiased history of this period is written he will find Robert M. La Follette rated far above the plutocratic, profiteering patriots who clamored for war, and shouted "stand by the president," while they were laying their plans to pile up millions by methods scarcely less reprehensible than highway robbery.

Mr. Bayliss says, "In war it is ours not to reason why, ours but to do or die."

I hold that this is a pernicious doctrine. It makes it possible for a vicious minority while congress is not in session, to plunge the nation into a war and thus muzzle or gag the loyal majority and brand them as traitors if they dare to oppose the declaration or conduct of the war.

We got our fill of this during the world war.

We were deprived of our constitutional guarantee of free speech, free assembly and free press, and on the slightest provocation many were cast into the government pens at Leavenworth or Atlanta and kept there until long after the war.

It was not so in the days of the Civil war.

Men sometimes get a beating

Men sometimes got a beating from some returned soldier, but they were not seized by the authorities and cast into prison, for disloyal speeches.

One of my neighbors, after conscription was started, declared that she would like to see a thousand bullets shot through Abe Lincoln's heart. But no one ever thought of having her arrested.

The members of this family afterwards became great admirers of Lincoln.

Mr. Bayliss also quotes approvingly, the language of Com. Decatur, "My country right or wrong."

It is our duty to maintain the integrity of our country and defend it against every foe, but it is not our duty to uphold our government in wrong doing. It is often the case that the worst enemies of our country are those who make the loudest professions of loyalty.

A better motto would be, "My country, right or wrong. If right to be kept right. If wrong to be made right." I am not certain as to the authorship of this quotation.

I quote again from Mr. Bayliss' letter: "In war, with every true American, it's 'country right or wrong.' It's this: Mr. President, I am with you. Democrat or Republican."

Mr. Bayliss will doubtless re-

member that this was the attitude of the Republicans during the war; but when it came to the settlement of the terms of peace they abandoned the president completely and so discredited him that he was unable to secure a just and reasonable settlement and Germany was forced to accept the most humiliating terms that have been imposed in modern times.

Germany was forced to admit that she was wholly to blame for the war.

Whereas, Earl Gray who, before and during the war stoutly maintained that Germany was to blame as since then said that they were all to blame.

Events that have transpired since the war and facts that have come to light, prove that on most points La Follette was nearer right than his traducers. And his bitterest opponents have acknowledged that he was sincere and honest; and he was certainly courageous, and his son is a chip of the old block.

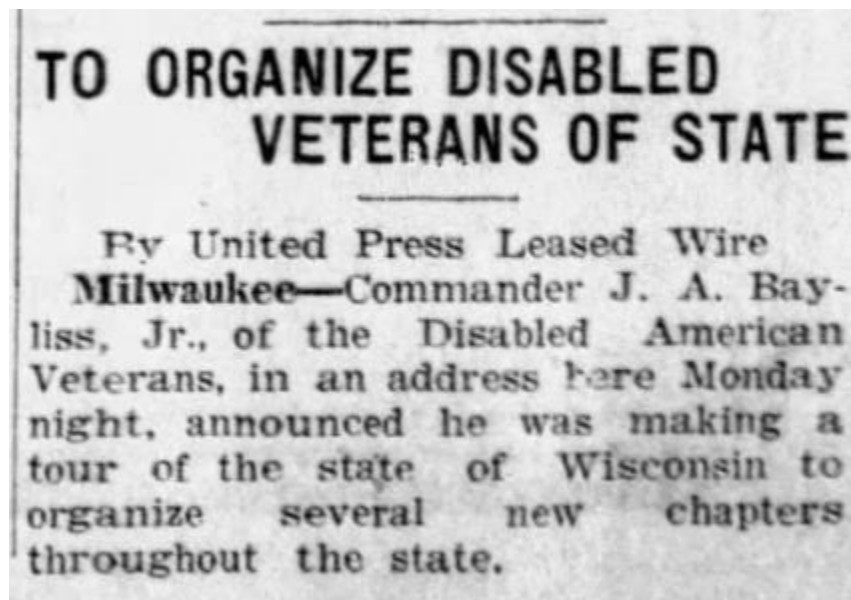

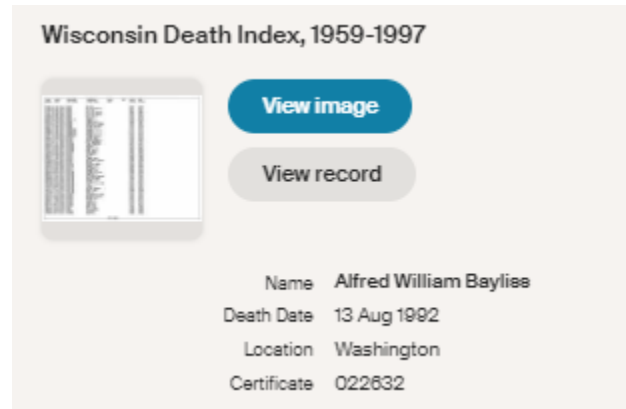

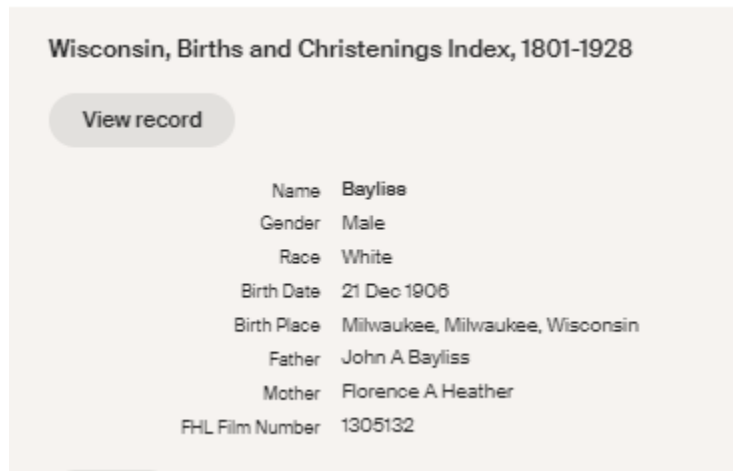
