The award was presented to a Treuter's widow, Mrs. Florance It Treuter, by Guy Chipman Jr., to board president, at the Realtor Week dinner. Chipman cited p Treuter for "devotion far beyond the call of duty over a long tiperiod of years in the interests of sports for young people and adults." A crack athlete in his pyouth, Treuter worked hard virtually all of his life to build interest in the sport of bowling both locally and nationally.







Divorce ends in suicide

A newly-divorced man died Saturday afternoon after shooting his exwife and wounding himself while they were dividing their property.

Manuel R Ricondo, 33, of 305 Sandmeyer St, died at Brooke Army Medical Center with a gunshot wound in the head, about two hours after arriving there.

His ex-wife, Mary Lou Ricondo, 30, late Saturday was listed in fair condition at Baptist Hospital with a gunshot wound in the left shoulder.

Neighbors said the Ricondos were divorced about two weeks ago.

The woman was staying with her mother at 1122 Mason St. and had gone to the Sandmeyer address to pick up items belonging to her, police said.

Witnesses said she went to the garage and Ricondo followed her there.

They said he pulled a pistol and fired twice at Mrs. Ricondo, hitting her once.



Pedro was wounded & gassed in WWI at the Argonne Woods. Painting was done by squads of Realtors working in shifts. Realtors urge homeowners to maintain their houses. Bob James, Realtor Week chairman, said the house, unpainted for years, was in the midst of well-maintained houses and now makes the area look better. On the day the house was painted, Pedro was at Brooke General Hospital for a minor operation. He lives there with his wife and four children: Mary Lou (18), a senior at Tech High who works after school & nights to help the family, Robert (16), also at Tech High, a part-time worker, 14-year-old Mathilda & 11-year-old Roger. Realtors hope other organizations will help indigent but deserving families. Pedro's wife takes in ironing as a job.
