He was a carpenter in home building. Living with them were their 2 daughters, an aunt & Gilberto's father-in-law Camilo Juarez.

Martinez. – In the 1950 census, living with wife Hilaria Martinez (1900-1985, F: 219614412) in San Antonio, Bexar TX. When Hilaria applies for naturalization on 12 Jun 1959, she says her birth surname was Martinez, she previously had surnames Izaguirre & Flores & she had married Julian Terrazas on 18 Jun 1942 in Hondo, Medina TX. - Buried in Mission Burial Park South, San Antonio, Bexar TX. F: 219614438
- Alfredo (Fred) Terrazas, 7 Aug 1909 Bexar Co. TX – 9 May 1937 Bexar Co. TX. His tombstone is inscribed with the birth year of 1907, which is an impossibility since his brother Julian Jr. was born 1 Jan 1907. Married 28 Aug 1933 in Bexar Co. TX to Encarnacio Cisnero (apparently also known as Conception de la Rosa) (1917-1954, F: 98572888). Died of a brain abscess. Buried in San Lorenzo Cemetery, Bexar Co. TX. F: 44888103
- Maria Encarnacio (Mary) Terrazas Trevino, 13 Apr 1912 La Perrita [San Antonio], Bexar TX – 20 Dec 2004 TX. Resident of Pearsall TX in Apr 1977 when her sister Adela died. Her daughter Maria T. Terrazas Ray was b. 4 Oct 1931 & died 1 Sep 1004 in Pearsall TX, the daughter of Juan & Maria Trevino. Buried in Eastview Cemetery, San Antonio, Bexar TX. F: 141412498
