

Mrs. Heyer contracted the malady from nursing her husband and was unable to attend the funeral. She is confined to her bed in a private sanitarium where no one outside of her mother and the nurse are allowed to see her.





Argyle Adams presented the program for 'Tuesday's meeting, choosing as her topic, "How to Be a Real Person."



# Motel tax could be hot council topic

DUNSMUIR — The second reading of the proposed transient occupancy tax could draw a crowd to the Dunsmuir City Council meeting Monday night at 7:30 p.m. in the Dunsmuir Justice Court chambers, according to city manager Bruce Crandall.

A tax of six per cent of the city motel operators occupancy will be charged motel room renters if the measure passes. Currently the rate stands at five per cent.

The city cancelled the council's November 21st meeting due to inclement weather conditions. A large turnout was expected to attend that meeting to voice their sentiments about the tax increase, according to the city manager.

The tax ordinance is expected to be read by title only Monday night

The council will also receive the resignation of Nick Melo as fire chief from the Dunsmuir Fire Department. Melo has been fire chief since January 1st, 1965.

A public hearing on the use of

revenue shring funds which the city is expected to receive in the future will also be held. The amount of funds the city will receive has not yet been determined, according to Crandall.

River Daze chairman Ken Clark will ask the council to waive an ordinance prohibiting the sale of liquor on public streets for the River Daze celebration next June 22nd, 23rd, 24th, and 25th.

The River Daze committee would like to set up a beer concession on Pine Street. The concession has previously been at the Dunsmuir Hotel.

Roy Haile will request additional money from the city for the chamber of commerce to help offset additional costs for the city brochure.

Other items on the agenda include the termination of the parking lot use north of the city offices, communication from J. E. Neal of Southern Pacific and a resolution authorizing the purchase of garage property from Isobel Jones.

Agenda topics will be accepted until noon on Friday. The final agenda will be publicized that afternoon.

# Dunsmuir increases motel-hotel tax rate

DUNSMUIR — The City Council Tuesday raised the hotel-motel room tax 1 percent and appointed a new fire chief.

The increase of the motel-hotel room tax from 5 percent to 6 percent had been opposed by most of Dunsmuir's motel owners. They contended that the hike would drive tourists away from the city.

Al Jensen, a motel owner, Tuesday urged the council to at least allocate the increased income from the tax toward promotion and advertising of Dunsmuir's attractions. He recommended billboard advertising.

City officials estimate the tax increase will bring an additional \$4,000

crease will bring an additional \$4,000 per year into the city's general fund. The council has made no promises about using the money for advertising or promotion.

City Manager Bruce Crandall argued that the room tax won't be a burden on the residents of Dunsmuir.

"We need it," he told five motel owners at the meeting.

Crandall, responding to the motel owners' worry that the room tax might be increased every time the city needs more money, said, "I can't tell you what we'll be doing next year."

The city manager announced that Bob Kenoyer, a 27-year veteran Dunsmuir volunteer fireman, had been appointed fire chief, replacing Nick Melo, who retired.

Kenoyer is purchasing agent for the Eskaton Mount Shasta Healthcare Center at Mount Shasta. He will receive a token \$100 per month salary as chief of the volunteer department.

In other action, the council:

Pusher began to grow and in 1890 Alexander Dunsmuir gave the town his name.

The flamboyant son of a Canadian coal magnate - his father owned the Wellington Coal Mines in British Columbia — Dunsmuir was traveling through in his private rail car when he was held over in Pusher.

He told the founding fathers that he would supply the town with a three-teared water fountain if the town would change its name to honor his family.

The fountain arrived and the name was changed. Dunsmuir never came back, but the name stuck and the fountain was installed in the depot yard

The fountain was built with a figure of a lady topping it. Around the turn of the century a caretaker left the water on at night. It froze and shattered.

The Dunsmuir fountain was nearly destroyed in the late 1960s when the Southern Pacific Railroad, successor to the old Central Pacific, decided to do away with the depot and the fountain. But Isobel Brunel Jones, former secretary of the Dunsmuir Chamber of Commerce, arranged to have the iron fountain parts stored and in 1973 the fountain was restored and placed in the city's Railroad Park.







Manual, a city fireman, accidentally kills his wife Kathryn with a shotgun in their home, exactly 7 years to the day since the Tuscania sank. He was loading a shotgun in order to kill rats around their house, while Kathryn was standing a few feet away. He had never shot a shotgun before & figured he accidentally left the "safety" off when inserting a shell. She was hit in the right side & was dead on arrival at the hospital. Manuel remarried after her death, but is listed as "divorced" in the 1920 census for Oakland, Alameda CA. He is age 48, b. CA, parents b. Portugal, a fireman for the fire department, a roomer. Retired as a fireman from the Oakland CA Fire Department. Married Mary Lou LaFollette Barr (1889-1983, F: 223085780), with whom he is buried in Park View Cemetery, Manteca, San Joaquin CA.
