



<p>"I am sending you enclosed a photograph of Spokane fellows who went through the Tuscania disaster, taken at Winchester, England, March 17.</p>	<p>"There is considerably activity in camp, and you will not hear from me again for some time, as I feel it in the air that we will move within a few days to France, and I will be glad when the call comes, as that little swimming party the Huns pulled off for us on the Irish coast has made us anxious for a chance to get even, and there are twenty-four hundred of us here that went down that have but one wish and that is to get at them and put Spokane on the war map.</p>
<p>"We have all been separated for several weeks, but I was able to get the boys together and thought you might be interested in seeing how this country agrees with us. You will notice the English military cap I am wearing. I lost any hat in the ocean and, as I wear a 73-8 the government failed to figure that a few fellows might get the 'big head,' and I had to take the cap which I am wearing.</p>	<p>"The inactivity of camp life does not appeal to me at all, and there is not a fellow in the gang that does not say 'we will get even if we get a chance.' 

CHARGE MONEY ORDER FORGING

**Thomas Toohey of Albany Hotel
Held for Grand Jury.**

Charged with forging a government money order Thomas L. Toohey, the 20-year-old son of Mrs. Mary Toohey, proprietor of the Albany hotel, W1022 Sprague avenue, was yesterday arrested by local federal authorities. He pleaded not guilty.

It is alleged by federal officers that the prisoner took from the mails a money order for \$6 destined for Harold A. Owen, a roomer in the hotel, and, forging Owen's name, cashed the order at the postoffice. Young Toohey has been employed as a helper in his mother's hotel.

Commissioner John L. Dirks held the prisoner to the federal grand jury with bond at \$500. It was stated last night that members of the family were raising the bond.

TOOHEY FREE IN FORGERY CASE

**Bankers Testify Chirography Is His
—Teacher Says Not.**

Thomas L. Toohey, aged 20, charged with forgery, son of Mrs. Mary Toohey, proprietor of the Albany hotel, W1022 Sprague avenue, was yesterday released by United States Commissioner John L. Dirks.

It was claimed by the postoffice inspector's department that Toohey forged the name of Harold Owen, a roomer in his mother's hotel, to a money order for \$6 and cashed it at the postoffice. Witnesses for the defense were produced who gave the boy an alibi, stating that he was in the hotel during the afternoon he is alleged to have cashed the money order. The prosecution introduced W. D. Vincent of the Old National bank and Julian O. Tiffany of the Traders' National bank as handwriting experts. They testified that the signature on the money order was Toohey's. Professor H. C. Blair of the Blair Business college testified that it was not. It was intimated in the district attorney's office last night that the case would be again brought up at the next session of the federal grand jury.

SPOKANE MEN ON VESSEL WHEN STRUCK BY TORPEDO

SIX MEN FROM SPOKANE ARE BELIEVED TO HAVE BEEN ON THE TRANSPORT TUSCANIA, TORPEDOED TUESDAY OFF THE IRISH COAST, LOADED WITH AMERICAN SOLDIERS. SERGEANT THOMAS E. LAVIN, GEORGE E. CLINK, THOMAS L. TWOHY, PERCIVAL M. BLAKE, F. B. MAGEE AND WALTER MAYBERRY, ALL OF SPOKANE, ARE KNOWN TO BE MEMBERS OF COMPANY F, SIXTH BATTALION, 20TH NATIONAL ENGINEERS (FOREST), WHICH WAS LARGELY RECRUITED IN THE NORTHWEST, AND WAS ONE OF THE TROOP UNITS ON THE TRANSPORT.

THE TWENTIETH ENGINEERS INCLUDES OVER 17,000 MEN, AND ONLY ONE BATTALION, THE SIXTH, WAS ON THE TORPEDOED TRANSPORT. THE FOLLOWING OFFICIAL COMMUNICATION WAS GIVEN TO THE ASSOCIATED PRESS EARLY THIS AFTERNOON:

"THE ANCHOR LINER TUSCANIA, CAPTAIN J. L. HENDERSON, WAS TORPEDOED ON THE NIGHT OF THE FIFTH OF FEBRUARY OFF THE IRISH COAST WHILE CARRYING UNITED STATES TROOPS.

"FOLLOWING ARE THE APPROXIMATE NUMBER SAVED: UNITED STATES MILITARY OFFICERS 76; MEN, 1935; CREW, OFFICERS 16; MEN 125; PASSENGERS 3; NOT SPECIFIED, 32. THE TOTAL NUMBER ABOARD, 2397; TOTAL SAVED, 2187.

"THE FOREGOING ARE APPROXIMATE FIGURES, BUT AS CORRECT AS CAN BE GIVEN AT PRESENT."

His name is spelled Thomas L. TWOHY in the "Spokane (WA) Chronicle" of Thursday 7 Feb 1918 p 1 – the captain of "Tuscania" was Peter McLean.

Fears were expressed yesterday that Thomas L. Twohy, Percival W. Blake and Walter Mayberry, Spokane men, were also on the Tuscania.

GETS SIX MONTHS ON THEFT CHARGE

Convicted on a charge of stealing auto accessories, Thomas L. Toohey, 27, a contractor, was yesterday sentenced to serve six months in the county jail on a petty larceny charge.

Toohey made a plea for leniency on account of his family, and it is possible that at least a part of the sentence will be suspended. Toohey claimed to have been intoxicated at the time he took blankets, tools and other articles from automobiles.

FORMER HUBBY ON LONE RIOT

HOQUIAM, Dec. 13.—Thomas Toohey is in the city jail today and police have several charges against him. He went on a rampage while intoxicated, last night, broke into the house of his divorced wife, who had fled earlier for fear of him; cut a new washing machine to bits with an ax; hacked holes through a kitchen stove; knocked a door off; smashed the outside casing of a heater; broke the cast iron interior; chopped up a radio; slashed bedding to pieces; stole a seal skin coat he tried unsuccessfully to sell; accused Ralph Howard with an ax when he tried to stop Toohey. Howard escaped, summoned police, they found Toohey several hours later in Aberdeen.



Smashes Wrong Car

ABERDEEN — A Hoquiam man picked the wrong car to smash into Monday night in Aberdeen, and the wrong people to run away from after an accident.

The man, Timothy P. Toohey, Olympic highway, crashed into a police patrol car and two other vehicles shortly after 11 p.m. near Heron and I streets. He then fled, in his car, but police officers weren't far behind.

Toohey's car, which he had borrowed from a neighbor, was found behind the Grayport tavern and Toohey himself was picked up in the tavern. He was booked as a disorderly person, and officers said he admitted driving the vehicle which crashed into the three cars.

Damage to the police car was estimated at between \$450 and \$500, while the other two vehicles were damaged to about the same extent, officers reported.

According to Foote, Toohey dashed out from under a bridge about 10:20 p. m. and attempted to halt a car driven by W. D. Bailey, Portland, an Indian Service employe. But Bailey didn't stop and turned over to sheriff's department an ex-

cellent description of Bailey.

Two and one-half hours later, officers from the Hoquiam police department and sheriff's office arrested Toohey at his rooming place. The rifle was found hidden in the grass in the front yard.

MONTESANO—Carl Stearns, 32, of Hoquiam, has pleaded innocent in Grays Harbor superior court to a total of 11 counts of forgery, grand larceny and second - degree burglary.

**Laborer Is Said to Have Divorced

LOON LAKE, Wash., Feb. 28.— Thomas Toohey, a laborer, and a man about 50 years of age, whose home is supposed to be in Spokane, died at a deserted cabin on the property of the Sheep Creek Land company, two miles west of Loon lake, last night.


