J. N. COLVER SENDS NEWS

Talks With Tuscania Survivors
From This City—Meets
Old Friends.

J. Newton Colver of The Spokes-
man-Review staff, now in Y. M. C. A.
service in France, writes to Spokane
friends under date of October 25:

Sees Spokane Survivors.

"I see that the German chancellor has protested against the unjust accusations by the allies of atrocities on sea and land. Well, I can quote some Spokane citizens now in this region as to the barbarities of German sea warfare. Lieutenant M. J. Urich and a dozen of Spokane survivors of the *Tuscania* are not many miles from my camp. I had a talk with the lieutenant the other day. He says that the English torpedo destroyer, the *Pigeon*, which took 700 off the *Tuscania*, was shot at four times by submarine torpedoes. The captain of the destroyer lumped 40 tons of oil into the sea to make standing room for every American soldier that could be wedged onto the boat. There was not room to sit down. The hold was as tightly jammed as the deck. There was no room for the movement of the guns on the deck of the destroyer and no possibility of its firing a shot.

MATCH COMPANY HAS BIG PLANS FOR DEVELOPMENT IN SPOKANE

Diamond Firm Announces Enlargement of Adminis- trative Staff Here.

Enlargement of the administrative staff of the Spokane department of the Diamond Match company and plans for the permanent operation here of the Diamond match block plant were announced late Thursday from the offices of the company, Old National Bank building.

The announcement is the result of a conference held here this week by officials of the company.

The Diamond Match company has assets totaling \$40,000,000 and has acquired about a half billion feet of standing white pine timber in the Spokane territory.

The Spokane lumber department will be operated by an executive bureau of three, including W. E. Bridgman of New York; B. H. T. Anderson and J. W. Blair, Spokane.

Mr. Anderson will continue as manager of the lumber department and will be assisted by the following staff: E. C. Olson, superintendent of production; Fred J. Anderson, assistant superintendent of production; Robert A. Wilson, timber supervisor and estimator; M. J. Uhrich, civil engineer; J. F. Grant, auditor, and J. J. Jensen, purchasing agent of supplies.

Miss Zella Hills of Eugene Dons
Jumpers and Learns All About
Motor Trucks.

NOW READY FOR REAL JOB

By Doing Real Man's Work and
Releasing a Fighter, Miss Hills
Feels She Is Doing Her Bit.

WANTED—Position as truck driver. Prefer
heavy vehicle. Best of references furnished.
Miss Zella Hills, first class mechanic.

Miss Zella Hills wanted to do a real
man's job. She looked over the field
and decided that to drive a great, big
motor truck was doing her part to bet-
ter advantage than taking a place in
an office, for a truck driver is a strong,
physically fit man, and to release a
man of that type meant another soldier.

Mrs. J. A. Hills of Eugene at first did not take kindly to the idea of her daughter, and thought it was doing the thing too thoroughly.

But mother and daughter came to Portland, and Miss Hills started out to learn all about trucks. She visited Del Wright, manager of the William L. Hughson company, and told him that she wanted to learn to drive a truck and to take a man's job in the world of commerce.

Determination Wins Trial

She was so absolutely determined that Mr. Wright thought there was little use trying to dissuade any ambition like that, so he gave her a time card and introduced her to Charley Dinsmore, service superintendent of the plant.

She was the first girl to come into the shops. Fellows, of course, aren't antagonistic, and they welcome a girl with pluck, but—well, most girls don't exactly fit into the scheme of things.

Miss Hills, however, demanded no attention. She donned jumpers and for just a moment watched the progress of things. As soon as she had watched some man at an operation long enough to grasp its idea she asked to be permitted to do it, and every time the man was only too glad to be released from some rather elementary operation.

Learned Tricks Readily

Miss Hills made an instantaneous hit. Any time someone comes along who is willing to do all the things that you are not particularly anxious to do, why, you are bound to be agreeable. And Miss Hills in turn profited, for the boys in the shop were more than willing to show her all the tricks of the service, and the quick repairs and speedy ways of finding out what is wrong.

She had driven cars before, so it was a simple matter to teach her the ways of handling a truck, and now she drives trucks back and forth from the William L. Hughson warehouse on the east side and the store on North Broadway.

After another week or so in the shop, devoted to study of electrical mechanism, she is ready for a job. She prefers one out of town, and the stronger the man she can replace the better.

"I wanted to do something that would release a fighting man," Miss Hills explained. "There are plenty who can do the lighter tasks, and I felt that I could well undertake work of this kind."

PENSION ANGLE RETARDS TRIAL

Legal battle over the property at E411 Sharp, which Anna M. Uhrich owned when she died January 1, 1946, was temporarily halted in Judge C. W. Greenough's court today while attorneys took time out to investigate what effect it would have on the case if Mrs. Uhrich was an old age pensioner.

Frederick A. Uhrich, Maurus J. Uhrich and Cecelia M. Cavanaugh, children of Mrs. Uhrich, have brought suit against the Catholic Near East Welfare association to quiet title to the property.

Testimony was that Mrs. Uhrich executed a deed to the association June 13, 1944, and gave it into the keeping of Mrs. Margaret Link, a neighbor. The deed was recorded January 2, 1946.

Mrs. Link testified Mrs. Uhrich had negotiated the sale of the property before her death, but did not sell because she hadn't been offered \$4000, which she thought it was worth. She testified Mrs. Uhrich was receiving an old age pension from the state.

James A. Brown, attorney for the plaintiffs, then moved to amend his complaint and stated that Mrs. Uhrich was a pensioner, since the state might have some claim against the property. Defense Attorney Lawrence Brown moved for a continuance.

TESTIMONY ENDS IN TITLE ACTION

Testimony in the suit of Frederick A. Uhrich, Maurus J. Uhrich and Cecelia M. Cavanaugh, children of Anna M. Uhrich, deceased, against the Catholic Near East Welfare association was completed in Judge C. W. Greenough's court today. The attorneys will submit written briefs in the case, they said.

The plaintiffs sued to quiet title to the property at E411 Sharp, which Mrs. Uhrich deeded to the welfare association June 13, 1944, and turned over to a neighbor.

Yesterday James A. Brown, attorney for the plaintiffs, moved to amend the complaint and the case was continued for that purpose. This morning he told Judge Greenough he would not amend the complaint.

HOUSE AWARDED UHRICH CHILDREN

Judge Charles W. Greenough ruled today in a memorandum opinion that Anna M. Uhrich, who died January 1 at the age of 89, had failed in her plan to make delivery of title to her home to the Catholic Near East Welfare association, New York, for the purpose of educating students for priesthood in the near east.

The judge's ruling gives the home, valued at about \$4000, to Frederick A. Uhrich, Maurus Uhrich and Cecilia M. Cavanaugh, children of Mrs. Uhrich. Her sons and daughter had brought suit against the Catholic Near East Welfare association to have the title cleared after the association had received a warranty deed to the title as directed by Mrs. Uhrich before her death.

Evidence showed the deed was not recorded until the day after Mrs. Uhrich's death.

Judge Greenough's opinion said: "From the evidence and all the surrounding circumstances I am convinced that Mrs. Uhrich did not contemplate a gift of the property itself to the association to do with as it pleased . . . It is clear that she intended the property to be sold and that she reserved the right to control the sale before her death, or after her death, through Mrs. Link (a neighbor).

"I am not insensitive to Mrs. Uhrich's lofty motives in this case and I realize that courts generally are favorably inclined to charitable donations. But this tendency on the part of the courts does not go to the extent of permitting an exalted purpose to supercede fundamental essentials to a gift."

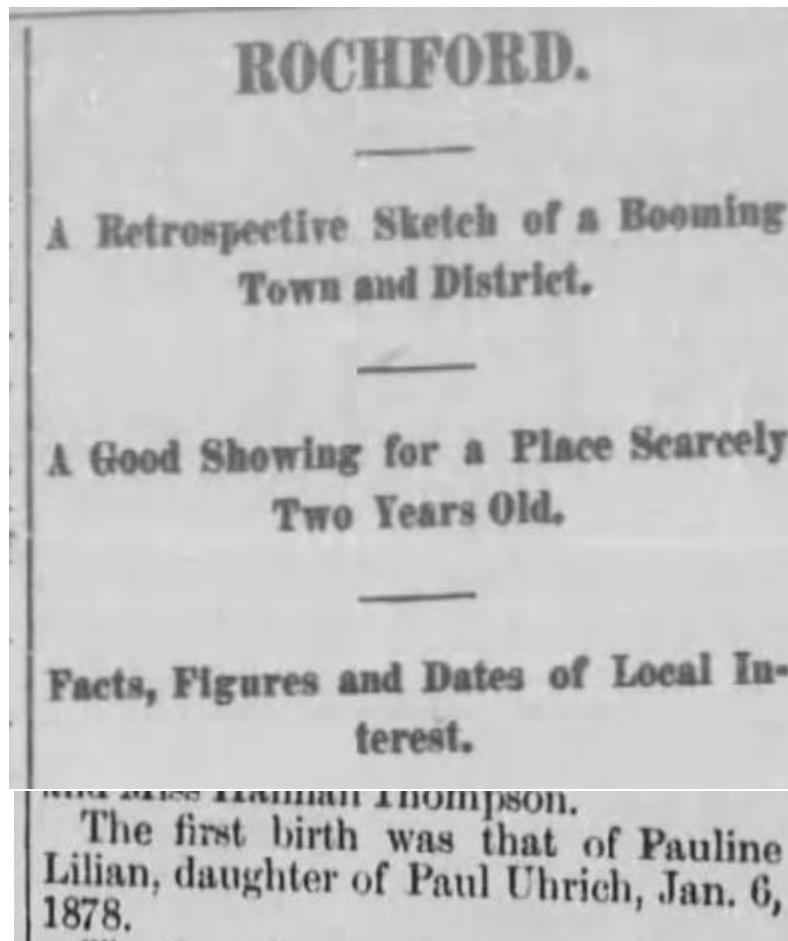

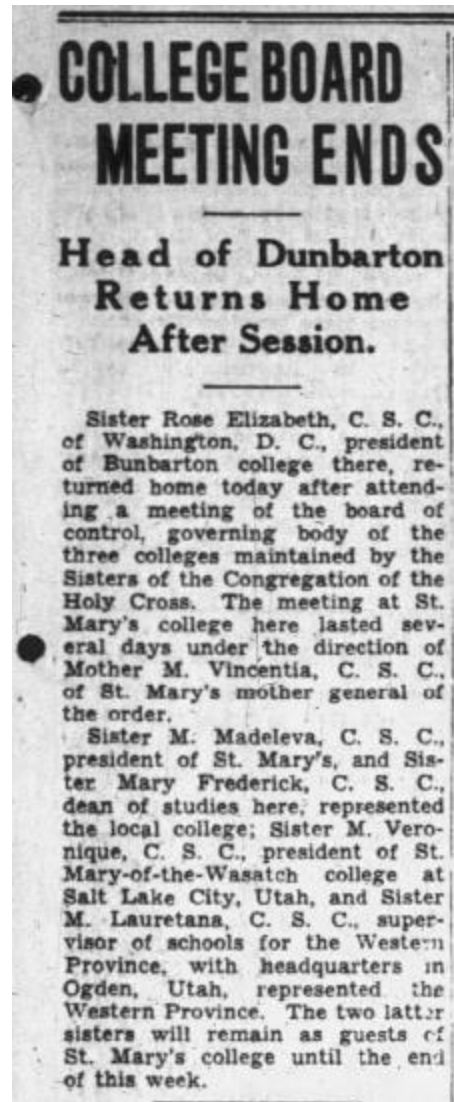

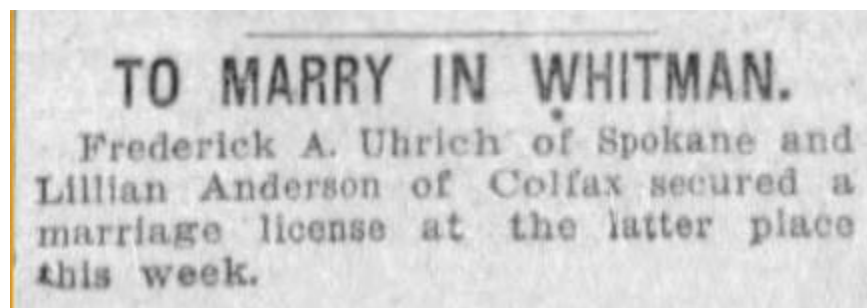

AFTERMATH OF MARRIAGE.

Mrs. Uhrich, nee Anderson, Telegraphs for Money to Return.

On the 4th instant Frederick A. Uhrich of Lewiston, Idaho, and Miss Lillian Anderson of Colfax were united in marriage in this city. Uhrich was manager of the telephone service at Lewiston and Miss Anderson held a position in the local telephone office. The courtship, according to report, was commenced over the long-distance telephone, and culminated in the marriage of the couple at the time above stated. They immediately left for Omaha. Monday the friends and acquaintances of Mrs. Uhrich (nee Anderson) were surprised when they learned that she had telegraphed to her mother, Mrs. H. Harper, for money to come home on, in fact, stating that she didn't have enough money with which to buy the next meal. The money was telegraphed and the young lady will soon be under the parental roof again.

From all that can be gathered Uhrich is a graceless scamp. He held a good position with the telephone company at Lewiston, and is said to have been short in his accounts in the neighborhood of \$1000. This sum the bonding company has made good, and there was a report that he was under arrest at Omaha, but this could not be verified. It seems that the young man has led a fast life at Lewiston, wine and the gaming table being alluring attractions. The deficiency, or most of it, it is said, was spent before his marriage. He is said to have had only money enough to take the two to Omaha. He was in a great hurry to leave here, and told his young wife that he had won \$300 at cards and that they were after him, and in order to avoid trouble he desired to leave town as soon as the ceremony was performed, which was done. It is now apparent that he did not want to face the charges of defalcation.

Uhrich has a widowed mother who lives at Spokane. It is said she has offered to give up her home (all she has) to the bonding company in order to save her son from going to the penitentiary. The full facts in the case will probably come to light in a few days. That he is stranded in the Nebraska city is apparent, and that he will land inside prison walls is evident unless the bonding company accepts the offer of the tender-hearted mother, which they may do. It is another case of a fast life and the evil consequences following. His marriage under the circumstances shows the graceless nature of the scamp. He is about 26 years of age.

On February 4 Frederick A. Uhrich of Lewiston and Miss Lillian Anderson, the Colfax belle, were married at the home of the bride's mother, Mrs. H. Harper, in this city. The courtship was commenced over the telephone. The bridal couple left ostensibly for Seattle, but went east and are now in Omaha. Monday Mrs. Harper wired her daughter \$45.

Miss Anderson was local manager for the Pacific States Telephone company and Uhrich was manager of the Lewiston office of the same company. It is now said that Uhrich had a discrepancy of about \$1000. His bondsmen made good the difference.

"MODEL YOUNG MAN" IS A FUGITIVE

Fred Uhrich Said to Have Forged City Warrants.

Two Bad Ones Turn Up and More Are Expected—Story of a Happy Little Home Gone to Smash.

Spun in a few weeks—from a woman at the bottom of it—from the placid height of the "model young man" to the dizzy depths of the drunkard and carouser, it is alleged, Fred Uhrich, an employe of the city controller, is being sought by the police on a charge of forgery. The warrants, one for \$100 and the other for \$90, have turned up in the office of the city treasurer, and on them both Uhrich is said to have represented clumsily the signatures of Mayor Seymour, City Clerk Edwards and Controller Meads.

Uhrich evidently has left the city. Detectives who followed on his trail today could get no recent trace of him. The two warrants were passed, one for \$100 on Kellogg's saloon, 11th and K streets, and one for \$90 at L. Schoenfeld & Sons, furniture dealers, 161-111 South 11th street. It is the belief of the city controller that at least three other forged warrants will appear.

Two complaints were made out against him in police court this morning, directly following the discovery of the forged warrants in a batch of countersigned slips from the bank. Assistant City Attorney Carnahan was notified at once, and, after consulting with Meads, immediate action was decided on.

Suspended for Drinking.

Uhrich, because of drinking, was suspended the first of the month by Controller Meads for 30 days. He begged so hard to come back that Meads allowed him to do so the latter part of last week. Monday, Uhrich forged the warrants and disappeared.

According to C. Wirges, proprietor of the Columbia Market & Commission company, in whose home Mr. and Mrs. Uhrich boarded a year ago, Uhrich was at that time a model young man.

"He and his wife seemed to be happy, perfectly contented," said Wirges this morning. "He very seldom took a drink or anything like that. In fact, my wife and I looked on him as a model young man."

His Wife Disappears.

"A few months after they left here to go to the Oakland addition, where they had bought a little cottage, Uhrich's wife left him. He declared he never knew the reason for it. He said they had not quarreled. She had just turned up missing one day, and that was all there was to it. He took to drinking hard after that and didn't seem to care much about things. I saw him the last time about five weeks ago, when he came around to my place of business. He was usually drunk when I saw him the last few months."

Uhrich is about 22 years old and was well liked by his many acquaintances in Tacoma.

Begged Hard for Work.

"I didn't want to let him come back until his 30 days were up," said Controller Meads this morning, "but he begged so hard and made so many promises that I believed the slight scare had done him good. I believe now that he simply returned in order to work this forgery. From what I have learned he drank so excessively that he ran out of money and was behind in paying his accounts."

In making out the false warrants, Ulrich was forced to forge the name of different city officials. One forged warrant read as follows:

Tacoma, Wash., June 5, 1912.

"By the order of the council of the city of Tacoma, the treasurer of said city will pay Fred Ulrich, or order, from the salary fund the sum of \$100, for May salary."

"Counter signed,
J. F. MEADS, City Controller,
W. W. SEYMOUR, Mayor.
Attest: HOMER H. EDWARDS,
"City Clerk."

All of these signatures were in writing and were forged by Ulrich. On the back Ulrich had endorsed the warrants in his own name.

Is Under Bonds.

Ulrich was under bonds with the Maryland Casualty company of Baltimore, Md. He and four other employees in the controller's office had taken out what is known as a "blanket bond," all being bonded under the one paper. The company will not be responsible, as the city did not cash the fraudulent warrants, discovering them before any payment had been made. The Maryland bond simply insured the city against loss.

Two More Forged Warrants Appear

Fred Uhrich, former clerk of the controller's office, is evidently somewhere in the Inland Empire, keeping a lookout for minions of the law.

The police discovered that he made his roundup with his alleged forged warrants Tuesday night. He is said to have visited a number of saloons and was finally landed at the depot. He paid Wright \$14.50 for a taxicab, took the train to Lakeview, there bought a ticket to Kelso and from there disappeared.

The third warrant showed up yesterday at the city hall.

This morning the remaining two warrants that were stolen from the controller's office showed up. Both were for \$90. One was turned into the Pacific National bank by Charles Helm and the other by the Olympia Brewing company.

The police in their investigations found that Uhrich had been living with a Texas Tommy dancer going under the name of Ruth Butler at the Butler hotel for some time until the proprietor compelled the girl to leave. She deserted Uhrich then and went to Victoria.

TEXAS TOMMY GIRL LED CLERK TO FORGE

ACTRESS THEN DESERTS CITY EMPLOYEE.

Gay Life With Vaudevillian Believed to Have Caused Uhrich's Downfall.

Infatuation for a Texas Tommy dancer recently on the vaudeville stage is believed to have caused Frederick Uhrich, clerk in the city controller's office, to forge city warrants for at least \$290, probably more. The dancer, who appeared on the bill of a local theater as Ruth Butler, is said later to have deserted Uhrich to go with a hotel keeper of Victoria, B. C. Uhrich's whereabouts are unknown.

The cashing of city warrants was not the only way Uhrich imposed on his friends, they declare, and he is accused of taking away with him amounts variously estimated at from \$300 to \$500.

It developed yesterday afternoon that Uhrich borrowed \$50 from Dwight Phelps, a salary loan agent, last Saturday, assigning his May salary warrant as security. Phelps appeared with the assignment at the city controller's office yesterday which was pay day at the city hall and learned that Uhrich had not been at work that day. Nothing more was heard from Uhrich until Delbert Scott received two warrants for \$100 and \$90 from a Tacoma bank which were apparent forgeries. Both were made out to Uhrich.

Schemes to Cash Warrants.

Another warrant for \$100 turned up yesterday afternoon from D. J. McGowen, proprietor of the Economy drug store at 11th and K streets, who said he cashed it for Uhrich Tuesday evening. Uhrich had paid \$20 on an account he owed McGowen and had received \$80 in change. McGowen said Uhrich appeared natural and not in the least disconcerted. The cashing of the warrant by McGowen was, especially well planned, as Uhrich had promised to pay something on a \$45 bill owed McGowen and agreed to bring up his salary warrant as soon as he received it. He appeared Tuesday night as he had agreed and the druggist was not in the least suspicious.

Uhrich's movements after he left the drug store Tuesday night have been traced by the police to the corner of 9th street and Pacific avenue where he hired a taxicab about 7:30 o'clock and first sent the driver for his grip and to pay his bill at the Butler hotel, 9th and A streets, where he had been living. "Curley" Wright was the chauffeur on the taxicab and he said yesterday that he drove Uhrich about from saloon to saloon until 11 o'clock when Uhrich alighted at the Union depot and paid his bill, amounting to \$14.50.

The proprietor of the Butler hotel, where Uhrich lived with the Texas Tommy dancer, told the police yesterday that Uhrich had lived high the last two months. The pair enjoyed elaborate midnight suppers, he said.

Too Noisy for Hotel.

The Butler hotel proprietor told the police he was forced to tell Uhrich a month ago either to leave the house or else to have the woman go, as other guests complained of the noise they made. The woman left the next day and returned to the Colorado hotel and a day or so later sent for her trunk at the Butler, ordering it carted to the Municipal dock to catch a steamer for Victoria. A receipt for the girl's trunk was signed by an elderly woman whose eyes were red as if from weeping and who gave the name, "Mrs. C. McArdle."

Uhrich is known to have parents living in Spokane and his father is said to own a mine in Idaho. The police have notified the authorities of all surrounding cities to be on the lookout for him and his arrest is expected hourly. Descriptions and pictures of the fugitive have been sent out in hope he will be recognized.

Wife Went Back to Mother.

Uhrich's wife left him last December from their home at 762 South 15th street, to go to her mother at Colfax. She left one day when he was away, neighbors say, and later sent him a letter saying she hoped never to see him again. She privately told her friends that her husband's drinking was more than she could stand. Uhrich took a turn for the worse after his wife left him, according to his friends. He drank heavier and heavier until Controller Meads was compelled to suspend him for 30 days about two weeks ago. Four days afterward he met Mr. Meads on the street and begged so piteously for his old job again that he was reinstated. He went to work last Saturday and the alleged theft of the blank warrants was planned at that time, the police believe.

When he came to work Monday it was noticed that he hung his coat and hat in a closet used by Mr. Meads' stenographer and which was situated near her desk. The blank warrants are kept on her desk and it is believed he took an entire sheet from the middle of the book as he reached for his coat and hat at a time the stenographer was away.

Once the blanks were obtained, the names of Mayor Seymour, Controller Meads and City Clerk Edwards were signed and the amounts were filled out on three at least. One was cashed at the Kellogg saloon near 11th and K streets, one across the street at the Economy Drug company and one for \$90 with the furniture house of L. Schoenfeld & Sons, 101-111 South 11th street. Warrants have been sworn out before Justice J. M. Arntson charging forgery and embezzlement.

Bringolf's Rings and Money Returned to City

Other people's money and wine, women and song helped to make fools of two young men, Harry Bringolf, who yesterday pleaded guilty to embezzling between \$10,000 and \$15,000 from the city, and Fred A. Uhrich, a clerk in the controller's office, who is being sought for the alleged embezzling of several hundred dollars.

Last night before the city commission, Detective Capt. Fitzgerald, Chief Loomis, Prosecutor J. L. McMurray and his staff, Harry Bringolf, confronted by Lou Evans, a notorious woman about town, and Doris Brown, aged 21, told how he had lavished the city's money on Dorris Brown, buying her diamond rings, picture hats, costly gowns.

In the city jail this morning she was stripped of the three diamond rings worth \$700 he had given her, and also of \$100 in gold. She did not seem to care as she stood smoking a cigaret and chatting with the officers, but she hated to lose the rings and the money.

Not only did Bringolf squander the \$14,879.43 stolen from the

city on these and other women, but he also used up his own salary and is alleged to have squandered \$4,000 of his wife's money. And last night she went to Commissioner Ray Freeland and laid \$743 in his hand, saying it was some of the money her husband had stolen and she would not have it. Now she and her little son have to face the world practically penniless, while Bringolf serves a term in the penitentiary and Uhrich dodges about the country fearing that he will be arrested.

The nightly carousals cost Uhrich his wife. She refused to live with him because he spent so much time and money drinking and away from home at night. Mrs. Bringolf stuck by her husband, kept lonely night vigils, prepared suppers that grew cold and were thrown away while she waited for the husband who was casting the city's money into the maws of professional gamblers. She even sat by the window with him in their little home on the East Side and consoled him while he waited for the detectives to come and arrest him.

BELIEVE BRINGOLF WAS BLACKMAILED

**One City Hall Thief Forced
Hush Money From Other,
Is Theory.**

UHRICH IS SUSPECTED

**Absconding Controller's Clerk
Is Said to Be One Prisoner
Had in Mind as Getting
"Blood Money."**

That Harry A. Bringolf, treasurer's teller and confessed embezzler of thousands of dollars of the city's money, was blackmailed by Fred Uhrich, absconding clerk in the city controller's office, is the belief of numbers of persons, who knew Bringolf intimately. Uhrich disappeared six days before Bringolf was caught, after issuing bogus pay warrants to himself for \$480 and cashing them. That he realized the time was near when Bringolf would be caught, and took the opportunity to drop out of sight after stealing a few hundred dollars himself, is common belief of friends of both young men.

Bringolf admitted Wednesday to his wife, father and Commissioner Ray Freeland that someone was forcing "blood money" from him. In answer to repeated requests for the name of the other man, he merely laughed. When Mrs. Bringolf sank to her knees and begged her prisoner-husband to confess the name of the blackmailer, he merely said: "What good would it do, dear? It would only get another fool into trouble and make a worse mess of things." He has since absolutely refused to tell the name of the person who knew he was stealing.

"Something on Bringolf."

Bringolf and Uhrich were together often the last three months. Uhrich assumed a magnanimous attitude towards Bringolf. The latter often declared that he detested Uhrich, yet when in company with the controller's clerk was most friendly. Men who knew Bringolf intimately say they suspected for several weeks that Uhrich "had something on Bringolf." They say that Uhrich obtained several large loans from Bringolf, but that they never knew of his having returned the money. Even after he was locked up, Bringolf referred to Uhrich as a "cheap sport," and said that he loathed him.

Believed He Spent More.

A partial itemized list of the manner in which he had spent the city's money, drawn up Friday night by Bringolf and made public by Commissioner Freeland yesterday, is said by men who knew Bringolf to be either incorrect or most carelessly ascertained. In the list Bringolf says he spent about \$1,000 in Seattle cafes. A friend of Bringolf said last night that he knew of nightly "joy parties" in Seattle by Bringolf, where hundreds of dollars were spent. This friend said that Bringolf's life in Seattle cost him far more than \$1,000. This man said Bringolf had at least three women in Seattle to whom he was making presents, besides two in Tacoma.

"Bringolf did not lose the greater part of his money by card games, or betting as has been reported," said the friend of the defaulter. "He blew in nearly everything on women. I am positive of this. The women called him an 'easy mark' and they 'worked' him for every cent he could dig out of the city's books.

"Crazy" on Dice Throwing.

"His single other craze was for dice throwing. In these two pursuits he has spent thousands of dollars. I will venture to say that if the city's books are completely checked, it will be found that he stole fully \$11,000 of that money since the first of this year.

"I knew he was going a fast pace, but he never so much as intimated to me how he was getting the money. He said his grandfather died in the East and left him \$20,000. He also told me he was keeping books for two local concerns, besides one of the Tacoma lodges, outside of his regular work, and was making as much outside of his working hours as he was getting from the city. I have seen him carrying home bundles of books in the evening and he told me he had some bookkeeping to do at home. Probably they were the city's books. I do not know."

Denies He Spent \$2,000.

In his list of expenditures Bringolf announced that he had spent \$2,000 over the counter of the Olympic club cigar store. This was denied last night by persons connected with the club.

W. H. Armstrong, manager of the club, said last night that Bringolf had not been near the place for nearly a year and a half. "About a year and a half ago Bringolf started to shake dice in the cigar store," said Armstrong. "Some one told Charley Bascomb, clerk in the store, that he was an employe of the city treasurer's office and he was playing stronger than we thought a man should in his position. Mr. Shreeder told me to take him into the office and talk to him, and I told him that although I didn't mean to infer he was stealing any money, he was in a position of trust and might cause people to talk.

"He replied, 'Why, it's my own money and I can do as I please with it.' He came in several days later and Mr. Shreeder took the dice box out of his hand while he was shaking it, in the presence of several people, including M. J. Lynch and J. E. Savage of the Savage Bros. Lumber company. He told him again not to play there. It was a year ago last winter and he has never played in the place since. He has told me several times that he was very grateful for what I had told him."

Prisoner Is Not so Jaunty.

Bringolf, occupying a separate cell at the county jail, has lost his jaunty and careless manner. His face is becoming haggard, and lines of worry are commencing to show. His walk is slow and drooping, compared to the sprightly step that he used when first arrested. He has requested that none of his friends come to see him. He repeatedly tells the officials that he has given out a full confession, and steadfastly refuses to tell more. With this ultimatum reached, it is possible that he will be taken into the superior court to receive his sentence tomorrow.

It was learned yesterday that Bringolf had committed forgery on the city's books besides stealing from the treasury. In one of the assessment rolls, where an assessment had become delinquent and he had stolen the money, he did not have enough funds to replace in the treasury to cover the loss before it went through the checking process of the controller's office. So he certified the balance himself, stamped it, and signed the name of Deputy Controller Harry Berryhill to it. The forgery was detected yesterday when the roll was being checked.

\$250 Reward for Uhrich.

With one commissioner voting against the motion, the city council decided this morning to offer a reward of \$250 for the capture of Fred Uhrich, controller's clerk, who left the city hurriedly after cashing forged city warrants to the amount of \$470. Owen Woods, commissioner of public works, cast the dissenting vote, declaring, "You can't pay out money for nothing."

Hit-Run Driving Charge Studied

ELY, May 7—Possibility of a hit-and-run driver being responsible for injuries suffered early Sunday morning by Fred Uhrich, Kimberly machinist, was being investigated here this week by county officers.

Sheriff J. E. Orrock said Uhrich was found early Sunday morning beneath the rear end of a machine parked in the Ely business district. Uhrich was taken to White Pine hospital by Jess Hildebrand. He was suffering from a severely lacerated face and an eye injury. Full extent of his wounds were not immediately determined. Orrock said the victim was not able to tell a coherent story, but that he would be questioned at length later on. Meanwhile officers are working on the theory that Uhrich may have been struck by a passing vehicle and thrown under the parked machine.
