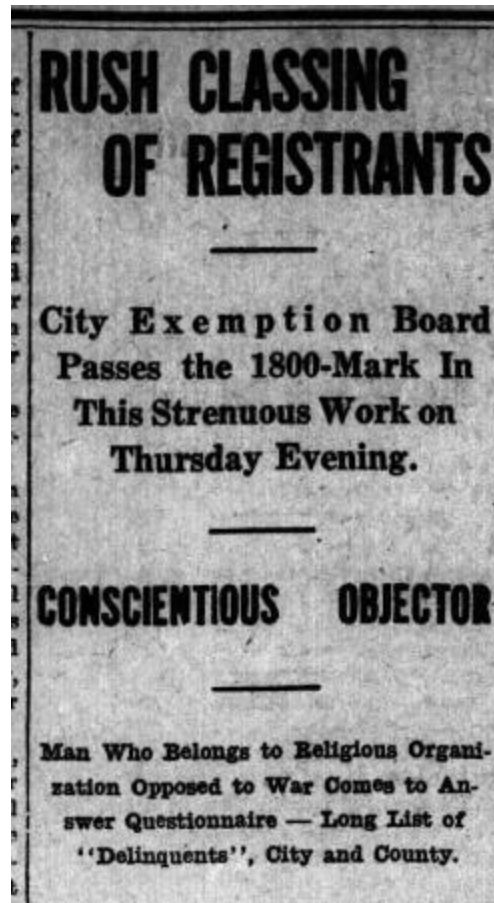
The board reelected the following officers: Henry G. Ruenzel, Milwaukee, president, and Edward Williams, Madison, secretary.

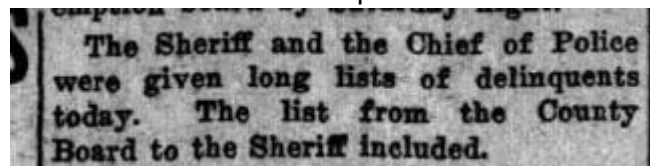

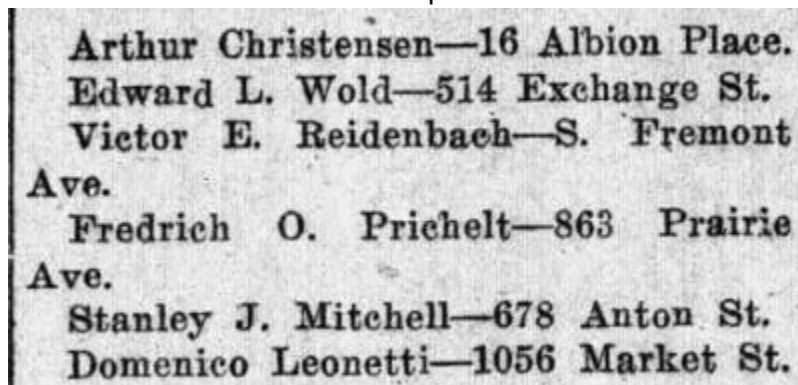

IN HEART OF HUNLAND.

Capt. Asbury Vale and Company Have Picture Taken at Marienhausen in Army of Occupation.

Kenosha soldiers who have served with Company B of the 107th Supply Train are going to bring back to Kenosha evidence that they fought their way into the heart of Hunland. The forerunner of it came today in a letter from Capt. Asbury Vale, now Executive Secretary of the Enemy War Materials Board with Headquarters at Coblenz but formerly commanding officers of Company B. The fore-runner is a picture of the company as it looked when stationed at Marienhausen, Germany, this winter as members of the Army of Occupation.

The photograph is one of the most interesting that has been sent back from Germany. All of the soldiers look to be in the best of health as has been characteristic of all of the boys who have returned from the service. At the extreme left is Captain Vale and behind him is Corporal Zimmer who drove the captain's car all through the fighting. In the extreme left hand corner is Sergt. Edward Wold, who for several days after the sinking of the "Tuscania" was believed to have been one of its victims.

A feature of the picture is the fact that in the extreme center is Private

Ju Syn, the Chinese American who has been with the boys from the start and who has been one of the favorites of the company.

The one hundredth and seventh supply train, which has seen wonderful service over in France under the command of Captain Asbury Vale of Kenosha and which contains some sixty Kenosha men did not return on the Louisiana on Tuesday and a new order of the War Department states that this unit of the 32nd Division has sailed from Brest aboard the battleship Virginia and it is due to arrive at Newport News on the morning of next Monday May 19th. As the transports with returning troops have been coming into ports in this country about a day ahead it is pretty probable that the word from these boys will begin to reach Kenosha about next Sunday at noon. The 107th will be on the last steamer bearing members of the 32nd Division from France home. It is probable that the men will be sent to Camp Upton to await order to move West to Camp Grant. It is not known who will be in command of the train since Captain Vale has been ordered back to Coblenz. The last roster of the Kenosha men in the 107th Supply Train showed the following:

Mark 30th Year For Company M

Thirty years ago this morning, Company M, Fourth Wisconsin Infantry, marched through Kenosha to the railway station and embarked on a trip from which many never returned.

Company M was the first infantry unit to be furnished by Kenosha during the war, although a cavalry troop, later converted to an artillery battery under Capt. John S. Coney, had left previously. The company was recruited personally by its company commander, Captain Ed Dayton, after other recruiters had given up the attempt as impossible.

The company trained at Camp Douglas, Wisconsin, Camp MacArthur, Texas, and Camp Merritt, New Jersey, before beginning its eighteen months of combat service at the front in France. In addition to Capt. Dayton, it was staffed by Lieutenants Asbury H. Vale and Francis A. Singer.

Part of the company sailed to Europe on the liner Tuscania which was torpedoed and sunk en route. Cpl. Arthur Junker was lost in this action, one of Kenosha's first casualties.

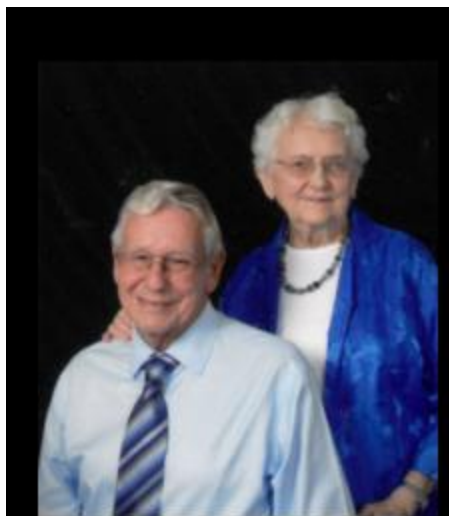

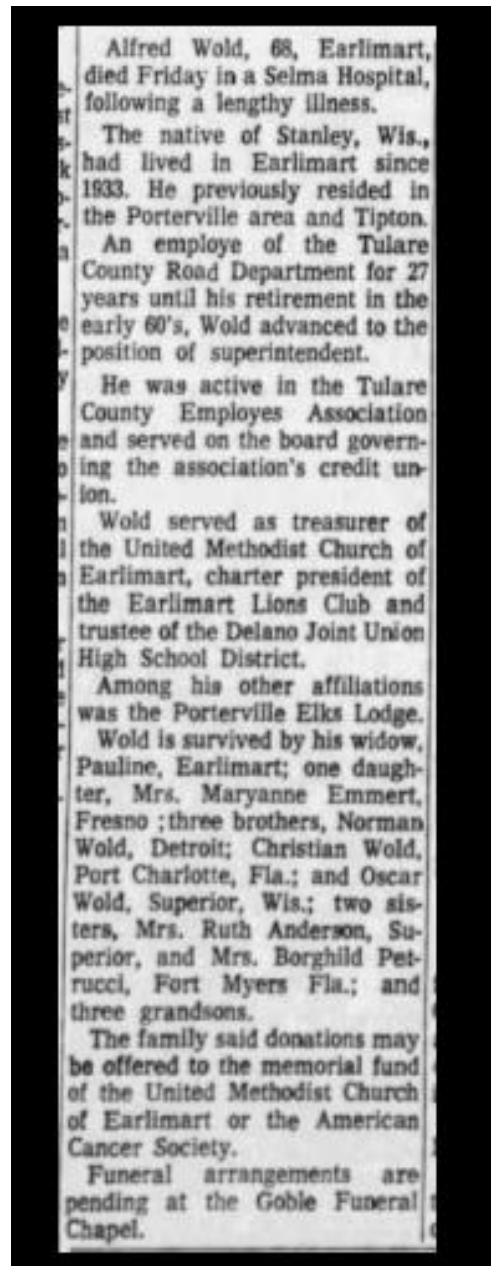
