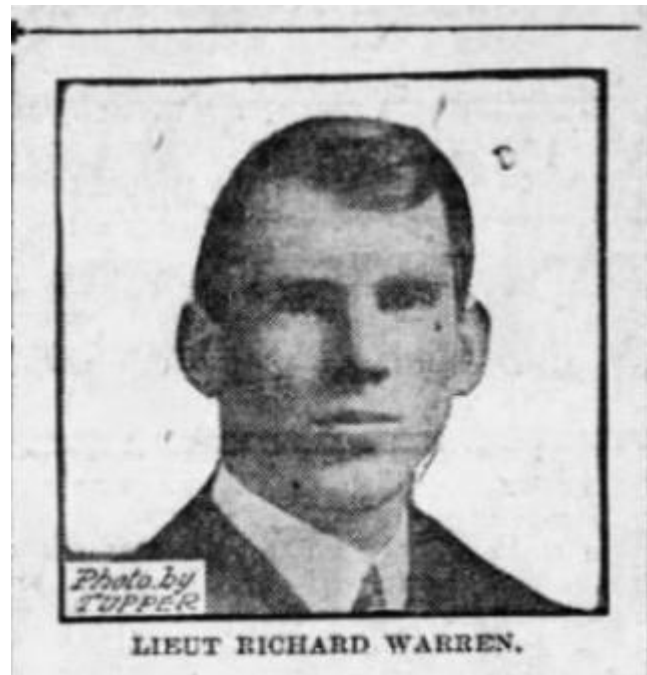
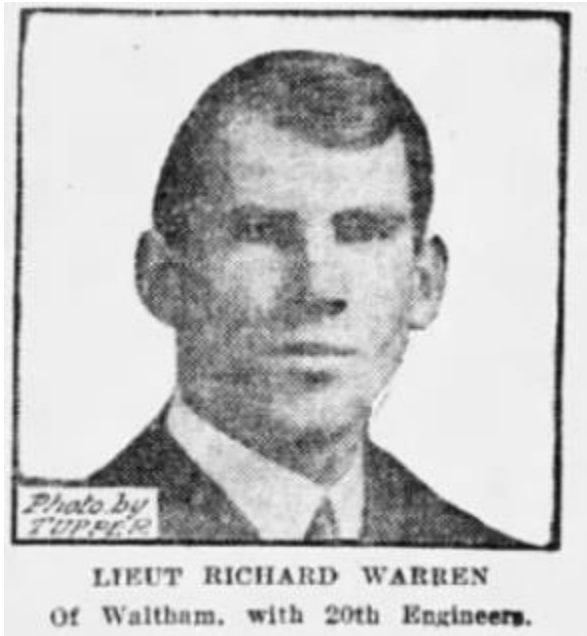

In October 1910, I entered the employ of the Boston Consolidated Gas Company as a clerk. Desire for work of an outside nature led me to take up the lumber business, first with the firm of Blacker and Shepard, of Boston, and later with the Dix Lumber Co., of North Cambridge. In January, 1914, I took up the wholesale end of the business with the Woodstock Lumber Co., of Boston, and spent the greater part of the next three years in Maine and Canada superintending logging and saw-mill operations and purchasing lumber. During 1917 I took charge of a retail lumber yard in Rhode Island for the same concern.

In the Fall of 1917 I was recommended for a commission in the 20<sup>th</sup> Regiment Engineers (Forest) which was then being organized for lumber operations in the forest of France to supply the Army with sawed lumber, railroad ties, piling and all sorts of forest products. On December 5, 1917, I received my commission as 2<sup>nd</sup> Lieutenant, and was ordered to active duty at Camp American University, Washington D.C., on December 19, 1917. Here I was assigned to Co. E, 6<sup>th</sup> Battalion, 20<sup>th</sup> Engineers, and sailed for France on January 24, 1918, on the SS Tuscania. On the night of February 5, 1918, the Tuscania was torpedoed by a German Submarine in the North Channel between Ireland and Scotland and sank in about three hours.

After being rescued by a British Destroyer and landing on the Northwest coast of Ireland, we proceeded to the Rest Camp at Winchester, England, for re-equipment, and then via Le Havre, France, to the American Engineer Camp at Angers, France. In April 1918, our battalion was attached to the British Army for forestry work and sent to Castets, Landes, where we operated three sawmills in the extensive pine forest South of Bordeaux. Shortly before the Armistice we were transferred back to the American Army and moved to two new operations at Labrit (Landes) and Captieux (Gironde). After the Armistice the whole 6<sup>th</sup>



Battalion was moved to Captieux and was engaged in cutting and sawing burned timber until May 1919.

On November 12, 1918 , I was promoted to 1<sup>st</sup> Lieutenant, and on May 8<sup>th</sup>, 1919 to the rank of Captain. On May 14, 1919, we embarked at Bassens, Port of Bordeaux, on the SS Santa Paula, and arrived at Brooklyn on May 28, 1919.

After a few days at Camp Merritt, New Jersey, we went to Camp Lewis, Washington, where the 6<sup>th</sup> Battalion, 20<sup>th</sup> Engineers, was disbanded. I then returned to Camp Devens, Massachusetts, where I was discharged on July 12, 1919.

In August 1919, I entered the employ of the Timberland Department of the Parker Young Co., at Lisbon, New Hampshire, where I am at present residing, although retaining my permanent address at 50 Weston St., Waltham, Massachusetts.

NORWALK — Richard Warren, 84, of 11 Saw Mill road, retired president of the Norwalk Fuel and Supply company, died yesterday in the Veterans hospital, West Haven.

Services will take place Monday at 10 a.m. in the First Congregational Church on the Green with the Rev. Henry K. Yordon, minister, officiating. Burial will be in Mt. Feake cemetery, Waltham, Mass. The Raymond funeral home, 5 East Wall street, is in charge of arrangements.

Mr. Warren was born in Waltham, Mass. and lived in Norwalk 41 years. He was a former treasurer for 21 years of the First Congregational church. He was an Army veteran of World War I and served as a captain with the 20th Engineer corps in France.

## Three Greater Boston Boys Believed to Have Sailed on Ill-Fated Liner

Apprehension among friends of American soldiers who might have been aboard the torpedoed Tuscania was somewhat lessened last night when reports to the effect that the number lost would be considerably less than was at first feared, were received.

The 20th Engineers (Foresters) was the largest regiment in the world, its strength being 17,300 officers and men. According to the cabled dispatches, however, only one battalion, comprising headquarters and companies D, E and F, was aboard. Many New England men are in the regiment.

Among the Bay State men aboard the Tuscania were Lieut Kenneth Standish Hall of Worcester, supply officer of the 158th Aero Squadron, and Lieut Richard Warren of Waltham, a member of Co E of the 6th Battalion, 20th Engineers.

Lieut Warren enlisted in Washington some months ago and trained at the American College, Washington, D C. He

## ***Larchmont Pilot, Radioman Dies as Plane Explodes in Air***

Second Lieutenant Lawrence S. Scofield, Jr., and Corporal John F. Brady of Larchmont were among eight men killed Saturday in the crash of a Flying Fortress near Tampa, Fla., The Associated Press said today.

Lieutenant Scofield was piloting the plane from MacDill Field, when it caught fire and exploded in mid-air. Corporal Brady was serving as radio operator.

Son of Mr. and Mrs. Lawrence S. Scofield of 137 Beach Avenue, Lieutenant Scofield had lived in Larchmont all his life. He attended Mamaroneck schools and graduated from Taft School in Watertown, Conn., later attending Lehigh University, where he was elected to Kappa Alpha Fraternity.

He received Air Corps training in Nashville, Tenn., Maxwell Field, Ala., and Harris Field, Mo., receiving his commission and wings last December at Stuttgart, Ark. He served as an instructor at Tyndall Field, Fla., until this Fall, when he was transferred to a unit

at MacDill Field for operational training.

Lieutenant Scofield is survived by his wife, the former Jeannette Biart of Norwalk, Conn.; his parents, and a brother, Midshipman William A. Scofield, USNR, stationed at Northwestern University Midshipmen's School in Chicago.

Corporal Brady, son of Mr. and Mrs. Francis J. Brady of 247 Murray Avenue, was born in Brooklyn and had lived in Larchmont about 18 years. He was a graduate of Mamaroneck High School, and before enlisting in the Air Corps during the Summer of 1942 received training at the Merchant Marine Academy, Fort Schuyler.
