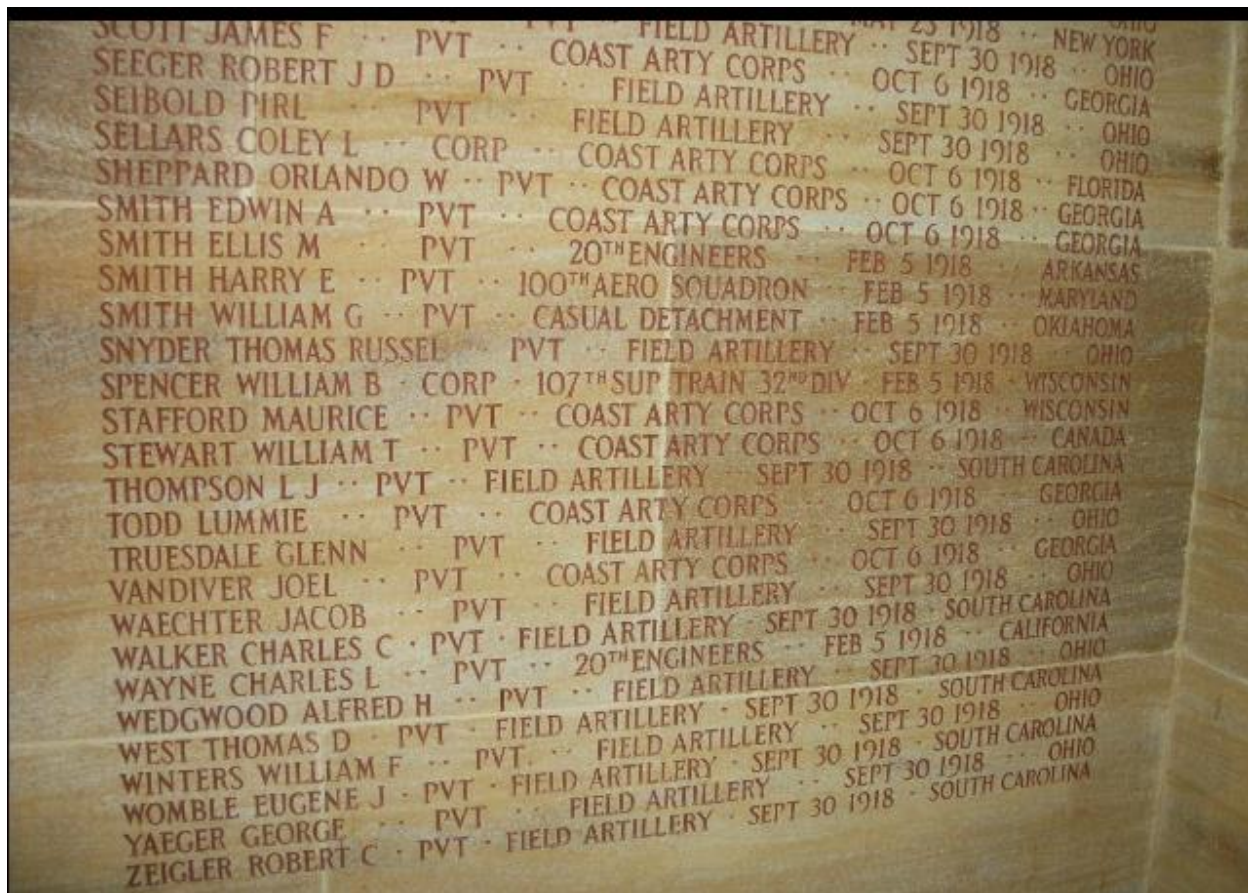

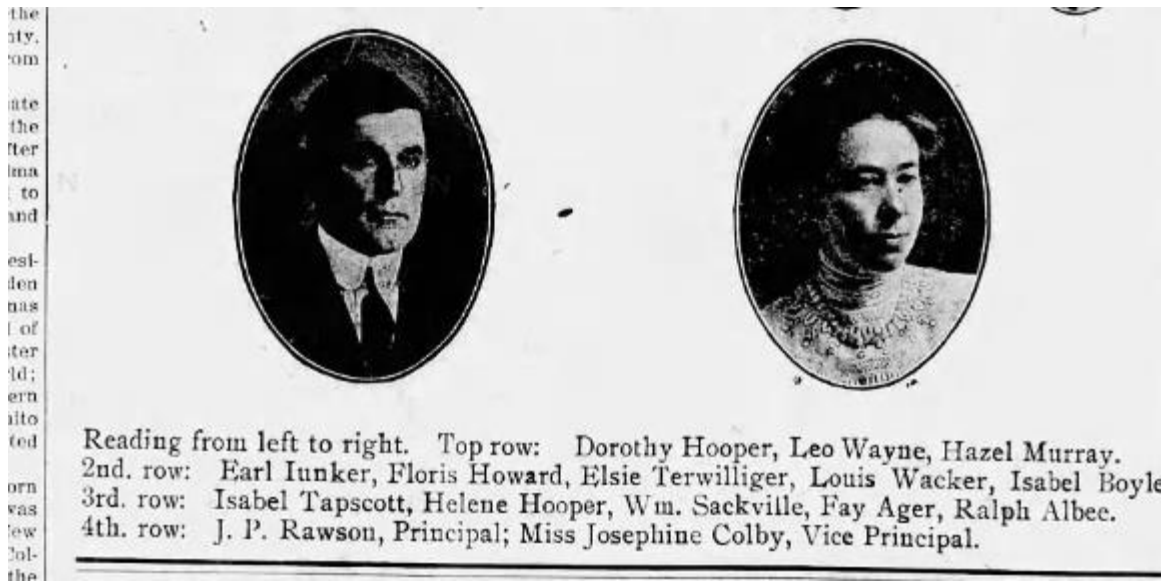

Dragged in Hay Field

Leo Wayne, aged 18 years, the son of a prominent merchant of Fort Jones, was badly injured Tuesday of last week by being caught in a hay rake when the team he was driving ran away on the Evans ranch, a short distance from the Fort.

The horses became suddenly unmanageable and ran through the field, dragging the rake after them. The boy was dragged along with the rake for about twenty-five yards.

He was picked up in a semi-conscious condition and given medical attention as soon as possible. He was in a stupor for several hours after the accident. When he recovered sufficiently to tell of the accident he said that he escaped death by rolling into the ditch. The latest reports are to the effect that he is getting better.

Young Wayne is a graduate of the Siskiyou county high school.

Fred Wayne, 74, well-known pioneer resident of Fort Jones, died Wednesday afternoon, April 11, at Siskiyou County General Hospital where he had been a patient the past four weeks.

Mr. Wayne, for many years in the mercantile business at Fort Jones, had sold his interest in the Byrne and Wayne Mercantile store there about a month ago.

In addition to his widow, Nettie, Mr. Wayne is survived by one son, Oliver G. Wayne, proprietor of the Fort Jones Creamery and Meat company, and one sister, Mrs. Emma Evans of Fort Jones.

Funeral services will be held Saturday at 2:30 p.m. from the Odd Fellows Hall under the auspices of the IOOF. Kunz Funeral Home is in charge of arrangements.

Prominent Resident Of Fort Jones Dies

Fred S. Wayne, the father of O. G. Wayne, proprietor of the Fort Jones Creamery, died in the Yreka hospital on April 11. O. G. Wayne brings butter and other dairy products to Dunsmuir each week and is known to many residents.

Fred S. Wayne was a well known Scott valley resident and was for many years a prominent merchant of Fort Jones. He had been in the hospital for many weeks, having been taken there for treatment for a broken hip. While he had not been too well, his condition was considered satisfactory until shortly before his death, and his passing came as a great shock to his family and to the Fort Jones community.

Funeral services were held in the Odd Fellows hall in Fort Jones at two o'clock Saturday afternoon, and interment took place in the Fort Jones cemetery.

Oliver Gilmore "Ob" Wayne, 73, of Fort Jones, was dead on arrival Monday at Mercy Hospital where he had been taken from his trailer home on Shasta Lake.

He had been under the care of a doctor for a heart condition, Glen R. Linn, Shasta County coroner, said today.

Wayne was born March 18, 1896, in Fort Jones. He operated the Fort Jones Creamery from 1913 to 1953. He was a member of the North Star Masonic Lodge No. 91 in Fort Jones, a 50-year member and past Noble Grand of the Fort Jones Odd Fellows Lodge, a member of the Siskiyou County Planning Commission from 1936 to 1954, a Fort Jones city councilman for 16 years and mayor of Fort Jones for 14 years.
