Applications from individuals, other than historians and statisticians, for information from this statement of service should be denied and the applicant directed to apply for the information to The Adjutant General of the Army, who is the custodian of the official records of the Armies of the United States. Exceptions to this rule may be made in the case of officials of patriotic and philanthropic societies and associations when it is known positively that the information is to be used exclusively by said society or association, and will not be made public nor communicated to any individual who may use it directly or indirectly as a basis for, or in the prosecution of, a claim against the Government, or to the injury of the soldier.

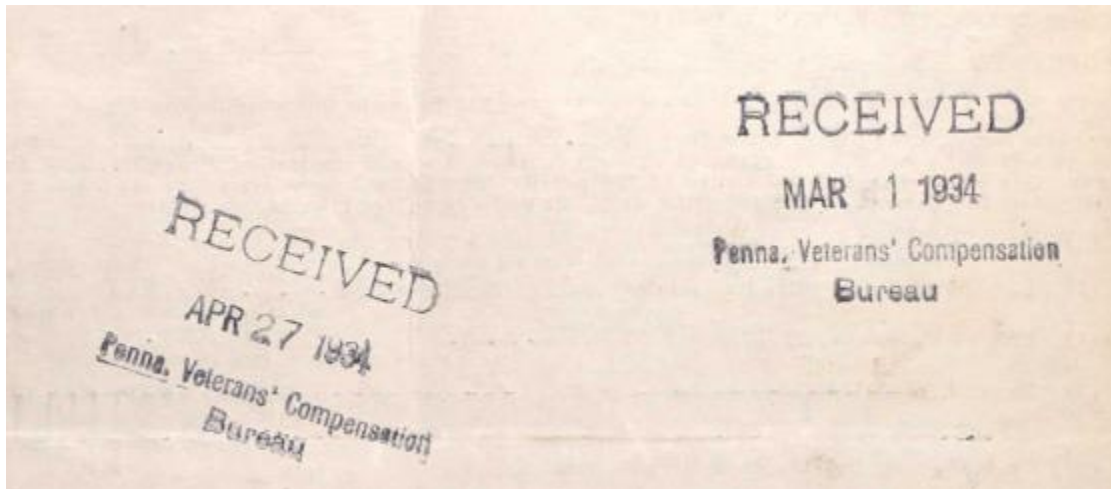

# Registrants Urged to Make Phone Calls, Arrange Car-Sharing

The complete list of all Victory Drivers registered in this great car-sharing campaign sponsored by The Star-Gazette is presented here today.

The method of using the lists is very simple. All that is necessary for a worker to do is to scan the list relating to his own factory and locate the names of several neighbors or others who live along the route he travels to work.

Several telephone calls to the other registrants ordinarily will produce mutually satisfactory riding agreements within a few minutes.

Then "Victory Driving" is all set. The car owners save on tires and gasoline and have the assurance that they have cooperated to the utmost in their government's wishes by saving these essential war materials.

The government has said, as has been reported several times, that car-sharing has become almost a necessity. Those who believe they are entitled to more than the minimum amount of gasoline after July 15 will be asked to prove in writing that they have completed arrangements to share rides with at least three other persons or that such car sharing is utterly impossible.

The Victory Driver campaign makes the problem a simple one. So why not use the master list published here today, make those telephone calls and begin sharing rides.

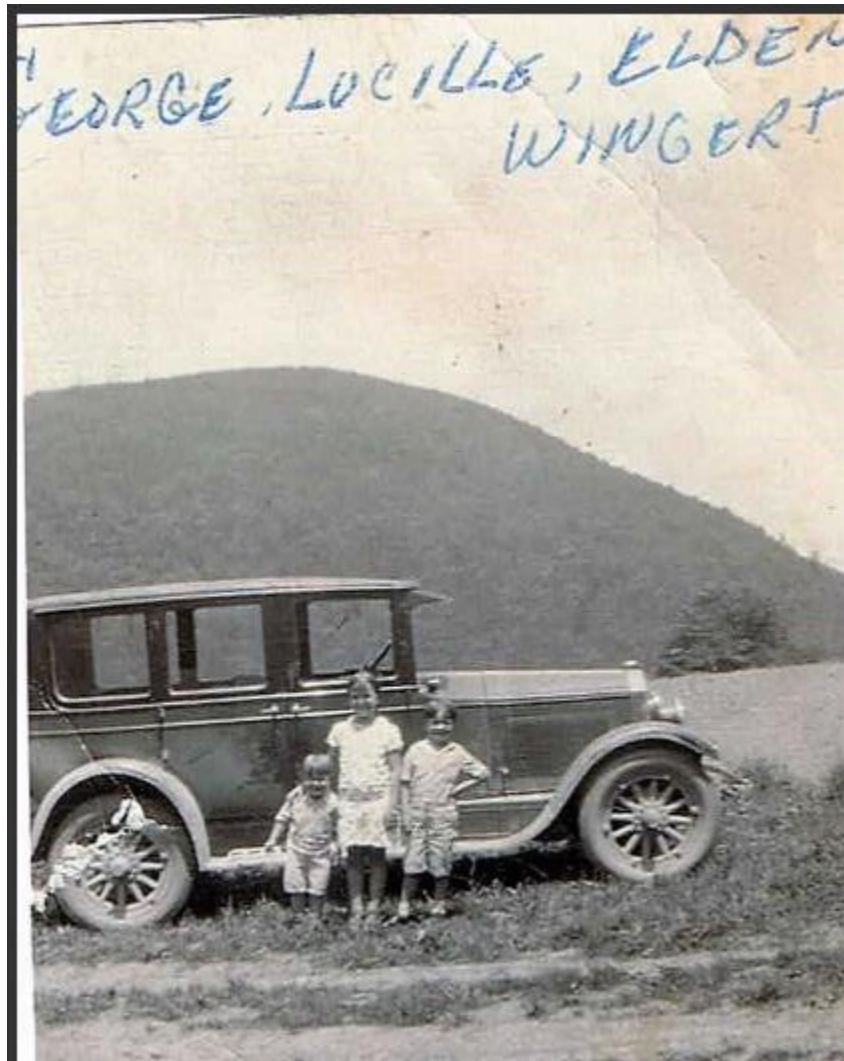
## Woman Hurt, Unattended For 6 Days

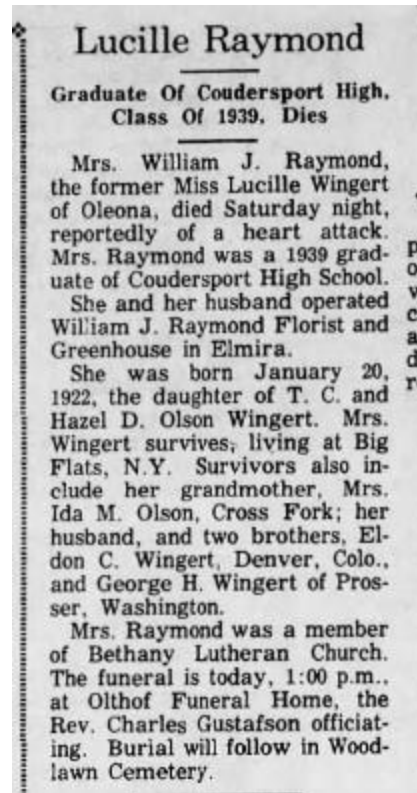

They start them in -with love of local romance early in Potter county. The little 2-year-old daughter of Mr. and Mrs. Carl Wingert, of near Oleona, wandered away from home Sunday and after searching parties had scoured the woods and streams about for hours she was found calmly sitting on the porch of the "old stone house" enjoying herself swinging, a mile from home, where her grandparents lived, who were absent. But little Miss Wingert took possession just the same and was restored to her frantic parents, who feared she had been drowned in Kettle creek, caught

in the nearby swamp or attacked by a bear. The "old-stone house" is one of the Ole Bull possessions at Walhalla, a monument of the ill-fated Norwegian colony which was wrecked on the rocks of a Potter county winter. The name Walhalla is a corruption, it is said of Valhalla, the "last valley" or heaven," in Norse mythology of Odin and Thor. It proved a "heaven" for little Miss Wingert, even after all these years.

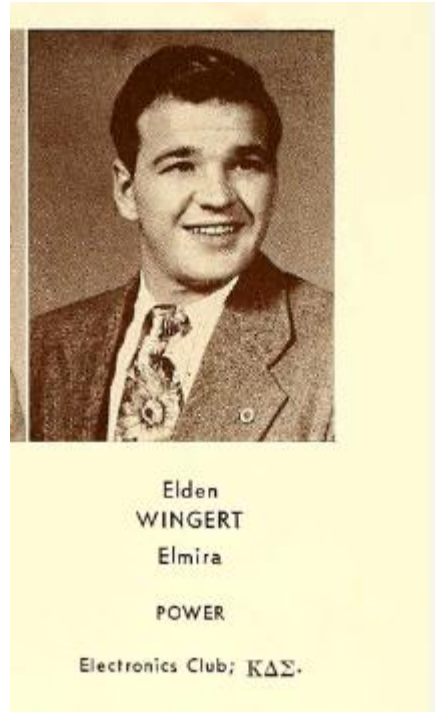

On Wednesday the sad news came from Rushford, N. Y., that Theodore Wingert, of Marchand, Indiana co., had shot himself at his home at that place. Later intelligence showed the report to be correct, he having placed the revolver to his heart and fired the fatal shot, apparently without any cause. It is thought his mind was affected, as he wrote a couple of pathetic notes to his wife before committing the rash act, and in these he stated that he believed he was insane. His body was brought to Punxsutawney yesterday evening, and the funeral takes place at Marchand to-day. Mr. Wingert was about thirty years of age, and leaves a wife and two small children. Theodore C. Wingert, who lived on a farm near Rushford, N. Y., committed suicide Wednesday morning, April 7, by shooting himself through the heart with a revolver. He got up early in the morning and wrote the following note, which he put in an envelope, sealed it and addressed it to his wife.

"These two checks are both yours, and everything else I have. I love you and the little children with all my heart but I don't seem to know what I am doing half the time. Good-by."

He then took a milk-pail and went to the barn. There he wrote a postal-card addressing it as follows: "My Dear Wife," and, writing the following message on the back, put it in the milk-pail: "I have done it all myself. I must be insane. You are a true and kind, loving wife, and I hope you will get along better hereafter than before. Your husband, T. C. Wingert."

After writing this he must have fired the fatal shot. His wife did not hear him get up, and when she arose she noticed the letter addressed to her. After reading it she started at once for the barn and found her husband lying on his face in the cowstable, dead. The revolver was beside him.

Coroner Sayers of Rushford was notified. He summounded the following jury: A. W. Lichard, foreman; Thomas Russel, B. J. Beacon, Timothy Davis, Charles Balcom and W. F. Benjamin. The verdict was in accordance with the above facts, the jury being satisfied that the deceased was temporarily insane. He leaves a widow and two children, the oldest 2 years old and the youngest 5 week old.

The remains were brought to this place Thursday evening and from here were taken to Marchand, Indiana county for burial, the funeral taking place on Friday.

The unfortunate young man was a son of Henry G. Wingert, and was a brother of Jeff. G. Wingert, Esq., a lawyer of this city.

lodge owner, dies at 98**

CROSS FORK — Mrs. Ida M. Olson, retired owner of the Olson Lodge here, died Monday at age 98, at the Snyder Rest Home, Westfield, Pa.

Mrs. Olson was a pioneer of the lumber era in this vicinity and had lived a long and active life in the Cross Fork-Oleona area.

The former Ida M. Bartholomew was born Sept. 28, 1873 at Marchand, Pa. She came to this vicinity as a young widow with two small sons, Lee J. and Theodore Carl Wingert, to work in the Windfall lumbering camp with her brothers.

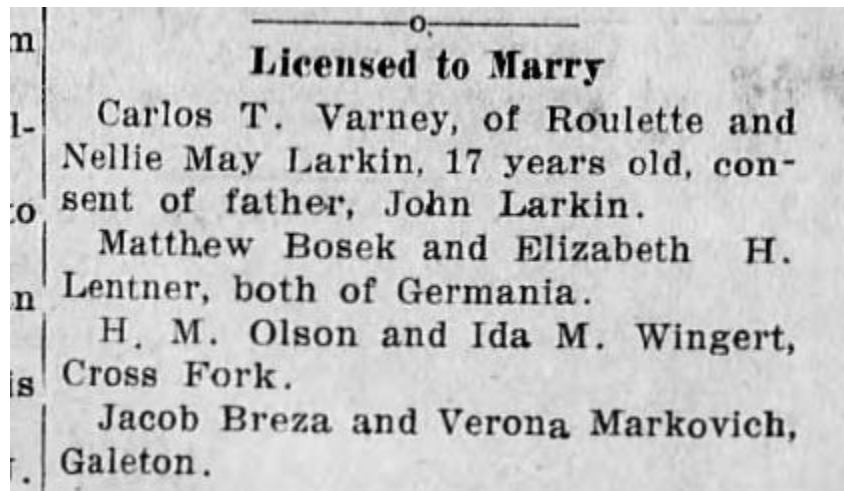
After the fire she went to live with the Olson family and married a son, Henry Olson, with whom she later operated the Olson Lodge until his death in 1938, and afterwards.
