Alta, In the 1909 Los Angeles CA city directory, John Caezza, laborer, resides at 3621 Pomona, as does Pauline, a laundress at the Sanitary Laundry Co, business address of 400 E.

- Pauline Caezza McKinnon (recorded as Paola on her LA birth record), 14 Nov 1887 New Orleans, Orleans Parish LA. - 27 Sep 1974 Los Angeles Co. CA. - Her mother died in 1899; in the 1900 census for New Orleans, Orleans Parish LA, a Pauline Caezza, 12 LA, b. Feb 1888, parents b. Italy, at school, resides with Louis Palazzolo (43 Italy) & his wife Concetta (37 Italy) & their 4 children. The birth month/year don't match. - In the 1909 Los Angeles CA city directory, John Caezza, laborer, resides at 3621 Pomona, as does Pauline, a laundress at the Sanitary Laundry Co, business address of 400 E. 3rd, presumably his sister. - Pauline married Harry H. MacKinnon 9 Jun 1908 Los Angeles, Los Angeles Co. CA. He was 23, b. OR; she was age 19, b. Louisiana, daughter of Dominie Caezza & Lucile Anino. – Her husband's name is actually Harry Patrick McKinnon, b. 17 Mar 1885, the son of John McKennon & Susan Goodnough. When he registered for the WWI draft on 12 Sep 1918, he resided at 1205 E. 59th St., was an auto mechanic & listed his mother Susan McKinnon as next-of-kin. Harry died 9 Aug 1938 in Los Angeles Co. CA. – In the 1910 Los Angeles, Los Angeles CA census, Harry P. Mackinnon, 25 OR, parents b. Canada (English), a starcher at a laundry, in his 1st marriage, married 2 years, and wife Pauline Mackinnon (22 LA, parents b. Italy, in her 1st marriage, has not given birth to any children, an ironer at a laundry) are listed as brother-in-law & sister-inlaw of George W. Mason (30 TX, father b. NY, mother b. LA, in 1st marriage, married 7 years, electrician, buildings) & wife Emily V. Mason (30 OR, parents b. Canada, gave birth to 1 child, 1 is living, an ironer at a laundry) & their son Raymond D. Mason (5 CA). - Pauline McKinnon is her brother William Caezza's WWI next-of-kin in 1918/1919. – In the 1930 census for San Antonio, Los Angeles CA, Harry MacKinnon, (46 OR, father b. Scotland, mother b. Canada, an auto machinist) has been married 21 years to Pauline (43 LA, parents b. Italy) in their household is son Robert G. MacKinnon (8 CA). – In the 1940 census for San Antonio, Los Angeles CA, the head of household at 1211 E. 59th St. is Robert McKinnon (18 New Orleans LA), a truck driver for a box manufacturing company. Living with him is his mother, Pauline McKinnon, 53 CA. Obviously, the birthplaces of mother & son were "swapped" as Robert was born in CA & Pauline in Louisiana. – In the 1950 census for South Los Angeles, Los Angeles CA, Robert G. McKinnon, 28 CA, never married, a clerk for a box factory, lived at 1221 E. 59th St., as did his mother, Pauline McKinnon, 63 LA, a widow. - Pauline's son Robert Glen McKinnon's obituary appeared in early Nov 1965.

Married John Vargona [sic] on 22 Dec 1970 Los Angeles, Los Angeles Co. CA. He was age 21, b. NY, to Cajalano Vargona & Conchetta Uchella (the same parents as those for Angelo Vergona, who married Katherine's sister Maria). John & Katherine's daughter Mildred, listed in the 1910 census, was born 1909 & died 1924 & is buried in Woodlawn Cemetery, Santa Monica, Woodlawn CA, F: 196348051. –

- Katherine's husband John Vergona (1886-1966) is buried in San Fernando Mission Cemetery, Mission Hills, Los Angeles CA (F: 257170146) as is wife Katherine Caezza Vergona, F: 257170181.

He is buried in St. Joseph Cemetery #1, New Orleans, Orleans Parish LA. Their daughter Lucille Mertz was born 1911 in New Orleans, Orleans Parish LA & died Dec 1937 in the same place. She too is buried in St. Joseph Cemetery #1, F: 140965107. – Married in Aug 1919 in New Orleans, Orleans Parish LA to Jean-Baptiste Bearmann (born 10 Jun 1896, died 7 Sep 1943, F: 135534529), the son of Edward Bearmann & Mena Wild. - As Christine Bearmann Caezza, age 49, daughter of Dominic Caezza & Lucille Annie, married 7 Feb 1944 in New Orleans LA to William Harry Maloney, Jr., age 44. Willliam was born 12 Oct 1899 in New Orleans, Orleans LA & died 12 Dec 1950 in Orleans Parish LA. - Cora/Corina Caezza Marino Wilson Pitt? Begg Sierra, 26 May 1895 New Orleans, Orleans Parish LA – 24 Nov 1999 Palmdale, Los Angeles CA. Cora was age 24 in the 1920 census. - Cora, age 25, married John Marino on 1 Jun 1921 in Los Angeles, Los Angeles CA. Cora was b. LA, resident Venice CA. John was age 37, son of Salvatore Marino & Cicilia Balsano, resident Venica CA. When he requests naturalization as a citizen on 19 Mar 1940, he is listed as Giovanni Marino. In addition to citizenship, which is granted 28 Jun 1940, he asked that his name be changed to John Marino. He was born 13 Mar 1881 in Siculiana Italy. He reported he had married Cora [no surname] on 1 Jun 1921 in Los Angeles CA, but they were now divorced. Her birthplace was New Orleans LA. - On 31 Jan 1923, Cora Caezza, a resident of New Orleans LA, married John Thomas ("John Tom") Wilson. He was age 40, a resident of Hayden, Gila AZ. He was the son of Franklin Wilson & Adelaide Powell & is buried in Arizona Pioneer Cemetery, Prescott, Yavapai AZ, F: 21673174, with wife Mary Elizabeth (Lizzie) Bratton (1882-1960, F: 478389250). - Listed as Mrs. Cora Pitt in her father's Nov 1928 obituary. – As Cora Wilson, 34 LA, parents b. Italy, status: married, she lived at 3751 Kelton, Los Angeles, Los Angeles CA as a servant to John R. Begg, 43 Scotland, parents b. Scotland, widowed, a carpenter at a picture studio (presumably motion picture studio). The word "employee" was crossed through & "servant" inserted. - The 1930 census was conducted on 12 Apr 1930. On 31 Dec 1930 Cora Caezza Wilson married her employer John Ritchie Begg (1886-1941) in Yuma, Yuma Co. AZ. – In the 1940 census for San Antonio, Los Angeles CA, John R. Begg (indexed as Bego), 53 Scotland, naturalized, a carpenter/repair-man for a soap manufacturing company, lived at 1215 E. 59th St. with wife Cora (44 LA). - Ca. 1945, she married Gabriel Sierra (1 Jun 1891 Spain – 16 Sep 1964 Los Angeles, Los

Angeles CA, F: 152082500). In the 1950 census for Randsburg, Kern CA, Gabriel Sierra, 59 Spain, a tungsten miner in a mine, lived with wife Cora, 54 LA. - Named as Mrs. Cora Sierra in Feb 1960 when her brother Joseph dies; resident of Palmdale CA. Wife of Gabriel Sierra. – Buried as Corina Sierra in Joshua Memorial Park, Lancaster, Los Angeles CA. F: 152082584.

• <u>Carmela/Carmille Caezza Guerino</u>, 14 Mar 1898 New Orleans, Orleans Parish LA - Listed as Mrs. Carmille Guerino in her father's Nov 1928 obituary; one obituary spells her surname as Gueino.
